ORDINANCE NO. 6808

AN ORDINANCE TO REPEAL AND REPLACE LVMC 1.16.020 TO 1.16.070, INCLUSIVE, TO UPDATE THE DESCRIPTION OF CITY WARD BOUNDARIES TO REFLECT PRECINCT-NUMBERING CHANGES MADE BY THE CLARK COUNTY ELECTION DEPARTMENT, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Repeals and replaces LVMC 1.16.020 to 1.16.070, inclusive, to update the description of City ward boundaries to reflect precinct-numbering changes made by the Clark County Election Department.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 1, Chapter 16, Sections 20 to 70, inclusive, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby repealed in their entirety.

SECTION 2: Title 1, Chapter 16, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto six new sections, designated as Sections 20 to 70, inclusive, reading respectively as follows:

1.16.020: Ward No. 1 shall consist of that area of the City which is encompassed within election precinct numbers 2013, 2025, 2028, 2030, 2032, 2033, 2036, 3000, 3003, 3007, 3009, 3011, 3013, 3039, 3043, 3045, 3062, 3068, 3361, 3750, 3753, 3754, 3764, 3765, 3773, 3863, 4009, 4027, 4612, 4615, 4623, 5533, 5554 and 6625.

1.16.030: Ward No. 2 shall consist of that area of the City which is encompassed within election precinct numbers 3014, 3016, 3017, 3018, 3021, 3022, 3027, 3363, 3364, 3366, 3370, 3373, 3374, 3382, 3385, 3391, 3392, 3544, 3557, 3565, 3576, 3740, 3755, 3762, 3763, 3793, 3800, 6007 and 6632.

1.16.040: Ward No. 3 shall consist of that area of the City which is encompassed within election precinct numbers 3038, 3069, 4020, 4026, 4387, 4540, 4541, 4543, 4547, 4548, 4605, 5001, 5002, 5003, 5005, 5007, 5012, 5014, 5018, 5022, 5028, 5030, 5031, 5044, 5350, 5384, 5542, 5545, 5562, 5563, 5565, 5590, 5903, 5905 and 6711.

1 **1.16.050:** Ward No. 4 shall consist of that area of the City which is encompassed within election
2 precinct numbers 2000, 3036, 3037, 3040, 3046, 3055, 3056, 3058, 3059, 3061, 3066, 3072, 3074, 3217,
3 3383, 3414, 3417, 3418, 3435, 3464, 3547, 3583, 3586, 3587, 3588, 3604, 3606, 3607, 3709, 3714, 3716,
4 3717, 3719, 3724, 3727, 3729, 3732, 3745, 3747, 3748, 3766, 3769, 3771, 3780, 3786, 3787 and 3989.

5 **1.16.060:** Ward No. 5 shall consist of that area of the City which is encompassed within election
6 precinct numbers 2003, 2004, 2005, 2009, 2011, 2014, 2015, 2020, 2021, 2023, 2029, 2037, 2046, 2063,
7 2709, 2710, 4000, 4001, 4007, 4008, 4014, 4015, 4019, 4028, 4030, 4032, 4034, 4038, 4040, 4041, 4461,
8 4463, 4510, 4526, 4528, 4529, 4604, 4613, 4633 and 4638.

9 **1.16.070:** Ward No. 6 shall consist of that area of the City which is encompassed within election
10 precinct numbers 2051, 2053, 2054, 2055, 2056, 2065, 2067, 2068, 2069, 2070, 2072, 2073, 2079, 2081,
11 2082, 2352, 2600, 2605, 2608, 2611, 2614, 2622, 2633, 2641, 2643, 2651, 2654, 2662, 2663, 2682, 2695,
12 2696, 2700, 2706, 2711, 2927, 2948, 3065, 3540 (those portions of the precinct located within the boundaries
13 of the City), 3545, 3546, 3574, 3602, 3613, 3700, 3705, 3706, 3730, 3781 and 3906.

14 **SECTION 3:** If any section, subsection, subdivision, paragraph, sentence, clause or phrase
15 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
16 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
17 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
18 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
19 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
20 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

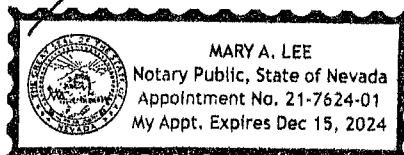
