PURPOSE/BACKGROUND:

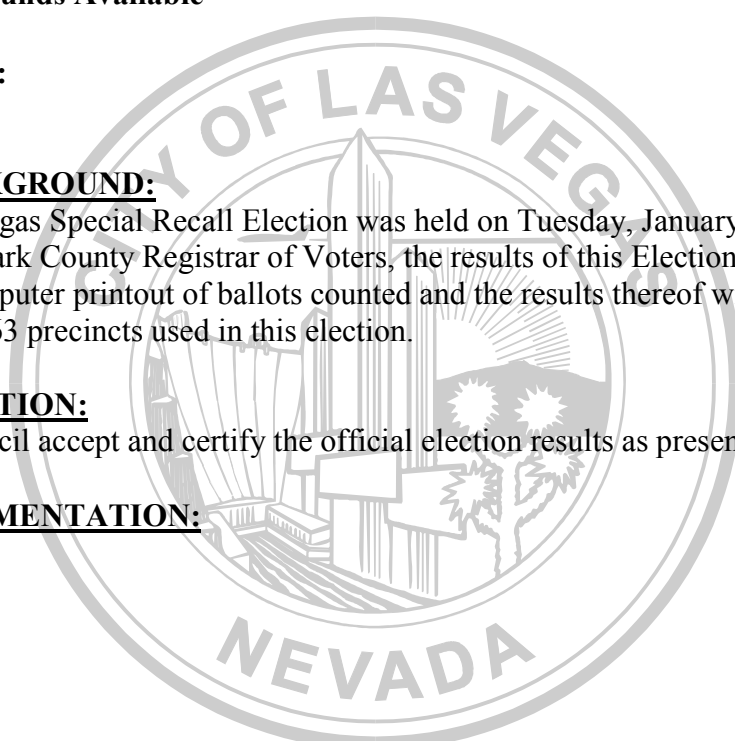
