OF STREET LIGHTS ON BUNKER COMMONS COURT (Ward 5 – Barlow)

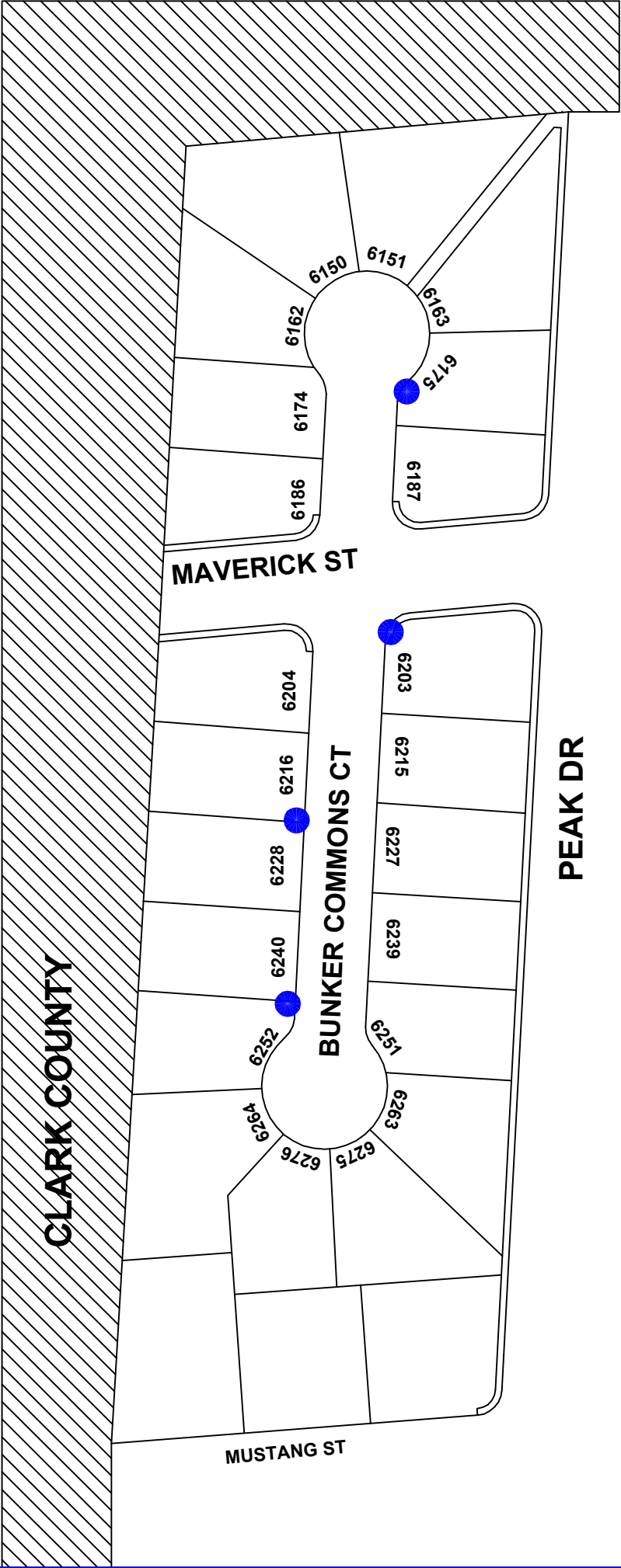
SITUATION

Some of the residents on Bunker Commons Court have requested the installation of street lights on their street. The Traffic Engineering Division sent a survey to the residents on Bunker Commons Court requesting their opinions. Since the response in favor of the street lights was not unanimous, staff is bringing the request before the Commission for discussion. Funds have already been set aside by the City of Las Vegas for the street lights, so the residents will not be responsible for paying for them.

RECOMMENDATION

The Traffic Engineering Division is in favor of the installation of street lighting on Bunker Commons Court.

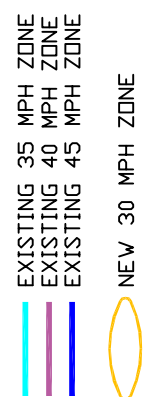
SITUATION

Several speed limit changes have occurred in Ward 6 as shown below. Staff is bringing these changes to the Commission and then to City Council for approval to update the Traffic Schedules.

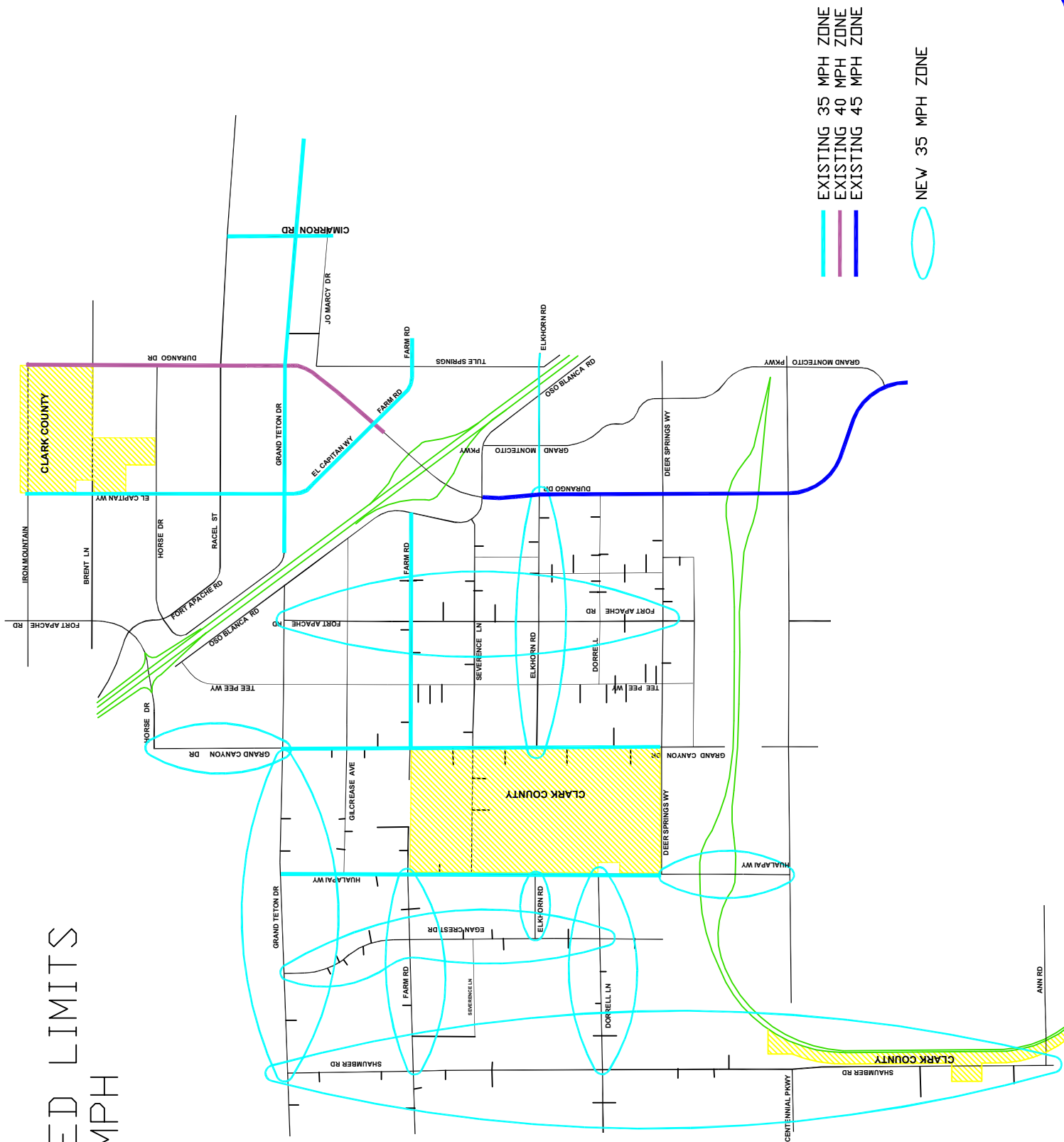
Deer Springs Way from Hualapai Way to Grand Montecito Parkway – 30 MPH
Dorrell Lane from Shaumber Road to Hualapai Way - 35 MPH
Egan Crest Drive from Dorrell Lane to Grand Teton Drive – 35 MPH
Elkhorn Road from Egan Crest Drive to Hualapai Way– 35 MPH
Elkhorn Road from Grand Canyon Drive to Durango Drive – 35 MPH
Farm Road from Shaumber Road to Hualapai Way – 35 MPH
Fort Apache Road from Dorrell Lane to Grand Teton Drive– 35 MPH
Fort Apache Road from Horse Drive to Iron Mountain Road– 40 MPH
Gilcrease Avenue from Hualapai Way to Oso Blanca Road – 30 MPH
Grand Canyon Drive from Grand Teton Drive to Horse Drive – 35 MPH
Grand Montecito Parkway from Durango Drive to Oso Blanca Road – 30 MPH
Grand Teton Drive from Shaumber Road to Oso Blanca Road – 35 MPH
Horse Drive from US95 to Fort Apache Road – 40 MPH
Hualapai Way from Centennial Parkway to Deer Springs Way – 35 MPH
Severence Lane from Grand Canyon Drive to Oso Blanca Road – 30 MPH
Shaumber Road from Ann Road to Grand Teton Drive – 35 MPH
Tee Pee Lane from Dorrell Lane to Oso Blanca Road – 30 MPH

The Traffic Engineering Division recommends approval to add these speed limit changes to the Traffic Schedules.

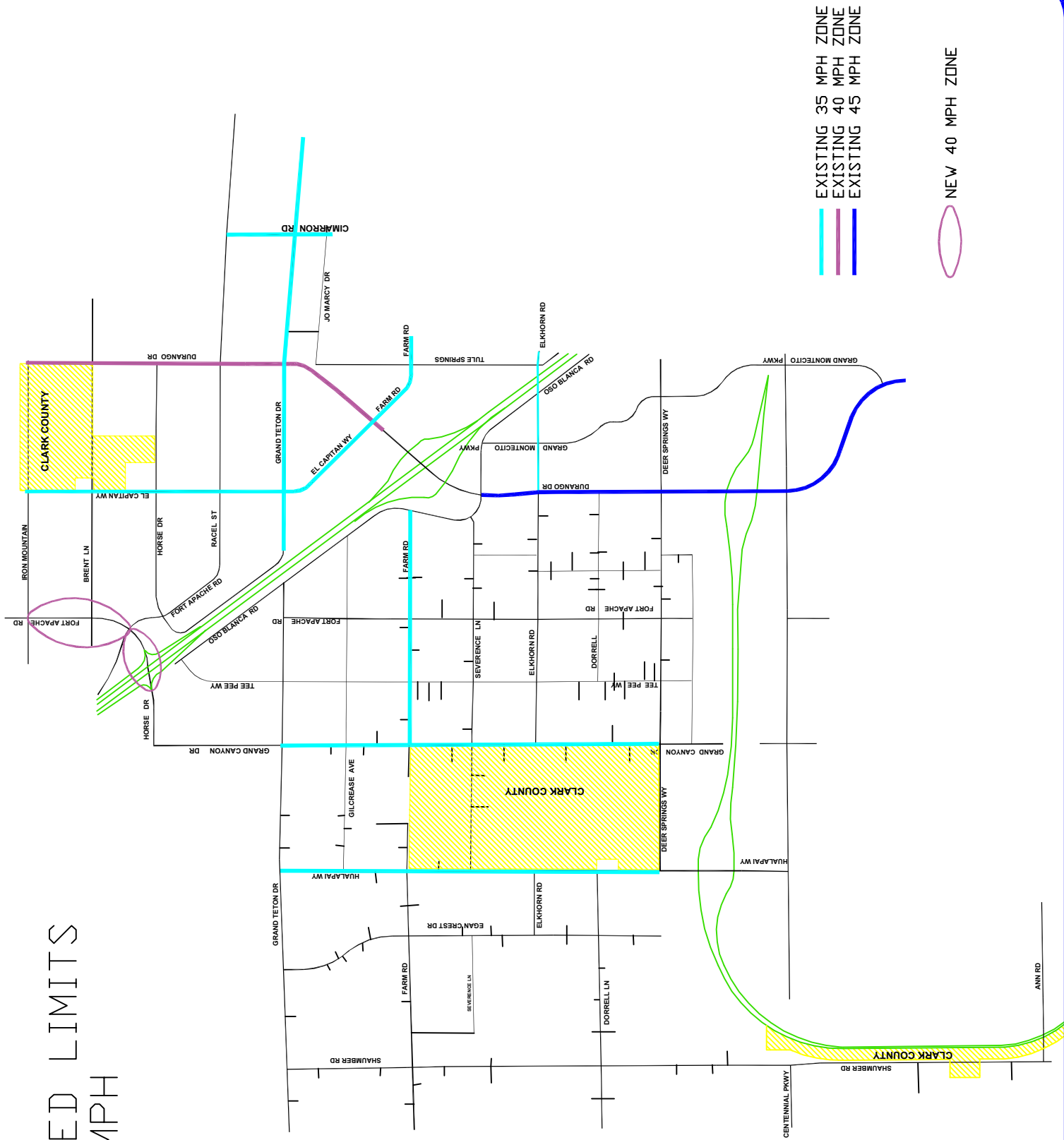


NEW SPEED LIMITS 35 MPH

SUBJECT: NEW BUSINESS: ITEM 7

ELECTION OF OFFICERS

The Commission annually elects a Chair and a Vice Chair from among the 7 appointed citizen members. All 9 voting Commissioners are eligible to vote in the election, according to 11.48.040 of the Las Vegas Municipal Code; a majority is required for election.

The Chair has no additional powers compared to the other voting members except to control the meeting. The Chair is not ever a designated spokesperson for the Commission unless specifically so designated by a vote of the Commission. The Vice Chair is to be subsequently elected from the remaining 6 appointed citizen members and serves as Chair in the event that the Chair is absent from the Commission meeting.
