3 AN ORDINANCE TO ADOPT A NEW TRAILS ELEMENT OF THE LAS VEGAS 2020 MASTER
4 PLAN, AND TO PROVIDE FOR OTHER RELATED MATTERS.

5 Proposed by: Flinn Fagg, Director of Planning Summary: Adopts a new Trails Element of the
6 Las Vegas 2020 Master Plan.

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
8 AS FOLLOWS:

9 SECTION 1: The document entitled "Trails Element" (including its accompanying
10 maps), which was approved by the City Council on January 23, 2013, is hereby adopted as a part of
11 the Las Vegas 2020 Master Plan and is incorporated therein by this reference. The document so
12 identified shall function as the element of the Las Vegas 2020 Master Plan that addresses trails from
13 both a recreational and transit-related standpoint, and shall replace and supersede previous elements
14 pertaining to transportation trails and recreational trails.

15 SECTION 2: The Department of Planning is authorized to:

16 (A) Include the date of the adoption of this Ordinance within or upon the document
17 referred to in Section 1 at such locations as are designed to reflect the date of the adoption of this
18 Ordinance;

19 (B) Publish the document in final form; and

20 (C) File the final document with the City Clerk.

21 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
22 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
23 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
24 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
25 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
26 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
27 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
28 invalid or ineffective.

SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.
