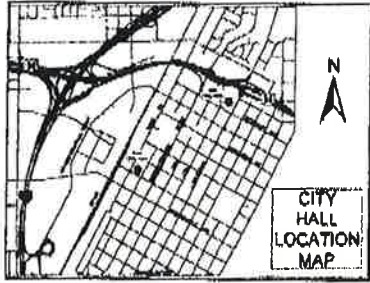

I copy this letter to the Planning Commission. I oppose the SUP 48455 for good reason, to wit:

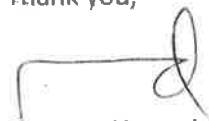
Bringing liquor to the corner in question does nothing to improve / upgrade our area, an area that has been heavily impacted by the recent depression, witness the fact that 10 of the 12 houses on my street, being Manistee Court, have been foreclosed, 8 of which now being investor owned and RENTED, not always to the best of tenants, hence the police were called to my street 3 times this week alone!!

We have a nice area, parks, and the like, and we need to accent safety and security, stability, and liquor does nothing to help, probably hurts - you must be mindful of the changing demographics in this area - we want to make it nice, not a barrio, leaving it a blight in your otherwise positive district.

A few months ago, there was even a shooting at a school bus drop off location just 100 yards from the proposed liquor store - arrests were made, someone went to prison - - we do not need a liquor store here now.

The corner of concern is much improved from what it was a few months back, and it should be allowed to remain the same going forward, at least until our area is more 'normal.' Liquor is not a high profit item, the store already sells beer and wine, and liquor is more of a headache than a benefit for the location. By the way, my family has been in the liquor business in the past, and I know it well - - we don't need liquor here now.
