ORDINANCE NO. 6812

AN ORDINANCE TO AMEND LVMC CHAPTER 2.20 TO AUTHORIZE THE DEPARTMENT OF FIRE AND RESCUE TO ENTER INTO AGREEMENTS WITH OWNERS OR OPERATORS OF VARIOUS TYPES OF PUBLIC AND PRIVATE FACILITIES BY WHICH THE DEPARTMENT'S PUBLIC SAFETY BOMB SQUAD OR OTHER SPECIALIZED UNITS WILL PROVIDE INSPECTION, SECURITY AND RELATED SERVICES FOR SPECIFIED EVENTS OR TYPES OF EVENTS; AUTHORIZE THE DEPARTMENT TO ESTABLISH AND CHARGE FEES IN CONNECTION WITH PROVIDING SUCH SERVICES; AND PROVIDE FOR OTHER RELATED MATTERS.

Summary: Amends LVMC Chapter 2.20 to authorize the Department of Fire and Rescue to enter into agreements with owners or operators of various types of public and private facilities by which the Department's public safety bomb squad or other specialized units will provide inspection, security and related services for specified events or types of events, and authorizes the Department to establish and charge fees in connection with providing such services.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 20, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 60, reading as follows:

2.20.060: The Department of Fire and Rescue is authorized to enter into agreements with owners or operators of public or private sports, recreation, entertainment, convention or other assembly facilities by which the Department's public safety bomb squad or other specialized units will provide, on a standby or nonemergency basis, inspection, security and related services for specified events or types of events. In connection with providing such services, the Department is authorized to charge such fees as may be set forth by resolution of the City Council.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the

1 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
2 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
3 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
4 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

5 SECTION 3: All ordinances or parts of ordinances or sections, subsections, phrases,
6 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
7 Edition, in conflict herewith are hereby repealed.

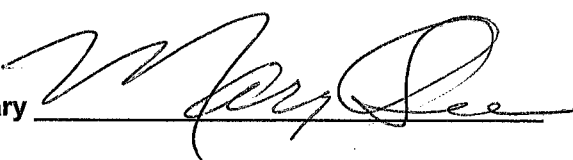

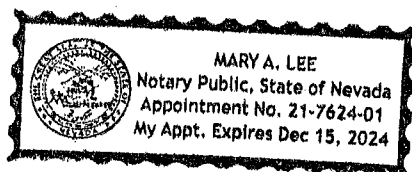
