3 AN ORDINANCE TO AMEND THE LAND USE TABLES ADOPTED IN LVMC 19.12.010 TO

5 ZONING DISTRICT BY MEANS OF SPECIAL USE PERMIT, AND TO PROVIDE FOR OTHER

Summary: Amends the Land Use Tables adopted
in LVMC 19.12.010 to provide that the use "Blood
Plasma Donor Center" is permitted in the C-1
Zoning District by means of special use permit.

9 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
10 FOLLOWS:

11 SECTION 1: Ordinance No. 6289 and the Unified Development Code adopted as Title 19
12 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby amended as set forth in
13 Section 2 of this Ordinance. The amendment is deemed to be an amendment to both Ordinance No. 6289
14 and the Unified Development Code adopted as Title 19.

15 SECTION 2: Title 19, Chapter 12, Section 10, is amended by amending Table 2 of the
16 Land Use Tables adopted therein to amend the entry for the use "Blood Plasma Donor Center" to indicate
17 that the use is allowed in the C-1 Zoning District by means of special use permit. In order to reflect the
18 amendment, the letter "S" shall be inserted in the box that represents the intersection of the row for the use
19 "Blood Plasma Donor Center" and the column for the C-1 Zoning District.

20 SECTION 3: For purposes of Section 2.100(3) of the City Charter, Section 19.12.010 is
21 deemed to be a subchapter rather than a section.

22 SECTION 4: The Department of Planning is authorized and directed to incorporate into
23 the Unified Development Code the amendment set forth in Section 2 of this Ordinance.

24 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
25 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
26 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the

1 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
2 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
3 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
4 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

5 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,
6 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
7 Edition, in conflict herewith are hereby repealed.

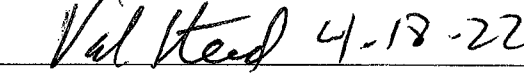

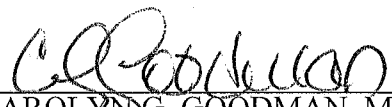

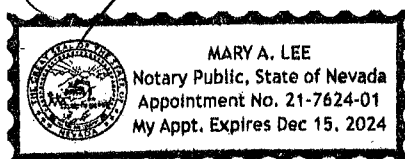
