CHAIR MOODY declared the Public Hearing open for Items 6-20.

**SPECIAL PLANNING COMMISSION MEETING OF: AUGUST 2, 2016**

ASSISTANT CITY ATTORNEY BRYAN SCOTT noted that General Plan Amendments (GPAs) require a super majority vote of five. Due to CHAIR MOODYS abstention for Items 9-12, ASSISTANT CITY ATTORNEY SCOTT advised the Commission that GPA Items 9 and 11 could be held until the next meeting or they could go ahead and vote, and the items would go forward to City Council as denials for failure to reach a super majority. He suggested asking for the applicants preference.

ATTORNEY STEPHANIE ALLEN, 1980 Festival Plaza, appeared on behalf of the applicant, DR Horton, for Items 9-12. She stated the preference would be to hold the items so as not to move forward with a denial. TOM PERRIGO, Director of Planning, pointed out that Items 9-12 would have to be held until the September meeting because it was too late for them to be placed on the August 9th agenda. He also clarified that Council would be briefed as to the reason for the denial. Taking this into consideration, ATTORNEY ALLEN stated they would like to move forward with the denial as long as the reason of lack of super majority was made clear.

CHAIR MOODY declared the Public Hearing closed for Items 6-20.
