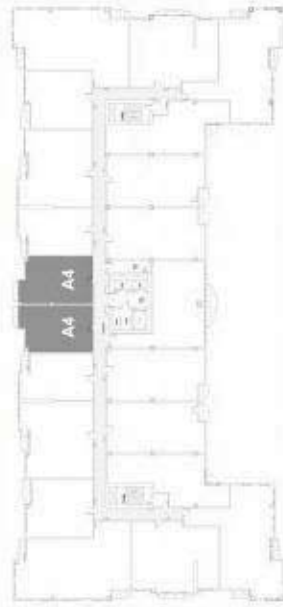


FLOOR PLANS

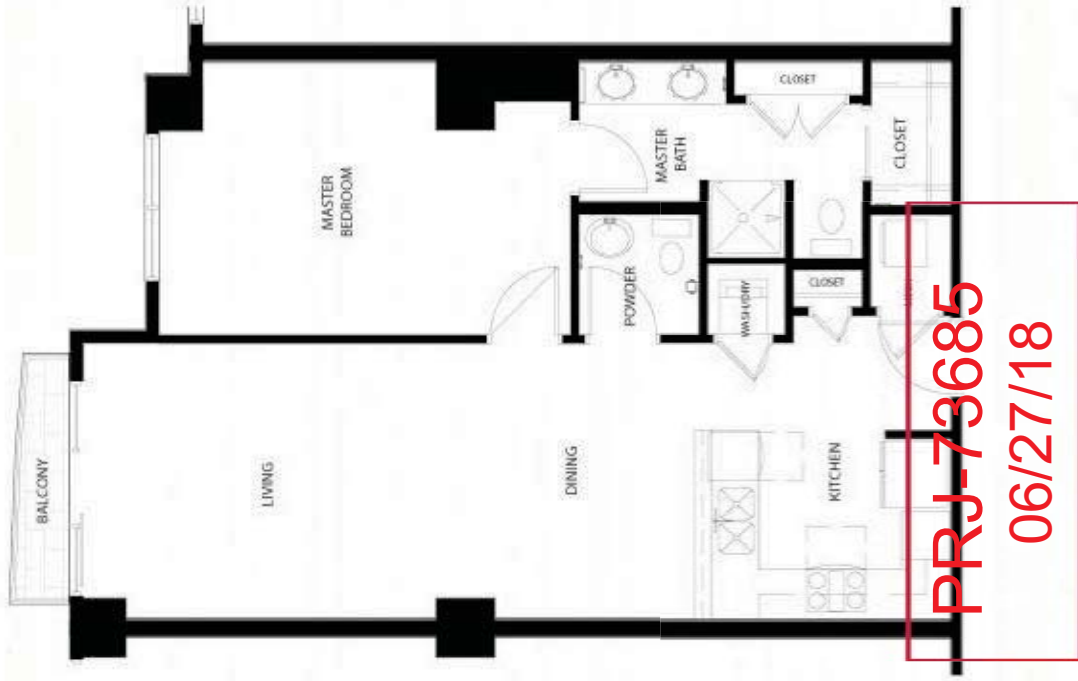
