CITY COUNCIL MEETING OF JUNE 21, 2017**

Dear Mr. Loh:

The City Council at a regular meeting held on June 21, 2017 voted to **APPROVE** a request for a Review of Conditions of an approved Special Use Permit (SUP-55282) TO ALLOW A DUAL USE MARIJUANA DISPENSARY on 0.16 acres at 823 South 3rd Street (APN 139-34-410-105), C-2 (General Commercial) Zone, Ward 3 (Coffin).

This approval is subject to the following conditions

Planning

- 1 Conformance to the approved conditions for Special Use Permit (SUP-55282), except as amended by conditions herein.
- 2 The following Conditions of Approval shall be revised as follows:
 - Delete the term "medical" from the following conditions: #1, 4, 11 and 17.
 - Delete Condition of Approval #2, 7, 14 and 16
 - Revise Condition of Approval #12: Approval of this Special Use Permit does not constitute approval of a marijuana business license
 - Revise Condition of Approval #13 This business shall operate in conformance to Chapter 6 of the City of Las Vegas Municipal Code
 - Revise Condition of Approval #15: This Special Use Permit shall be reviewed as a public hearing in two (2) years from the date of issuance of the Business License at which time the City Council may require the termination of the use. The applicant shall be responsible for notification costs of the review. Failure to pay the City for these costs may result in a requirement that the use be removed.
 - Revise Condition of Approval #18. Conformance to all regulations pertaining to Marijuana Establishment found within Nevada Revised Statute (NRS) 453A and 453D, and Nevada Administrative Code (NAC) 453A and 453D

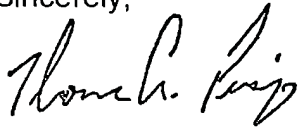
