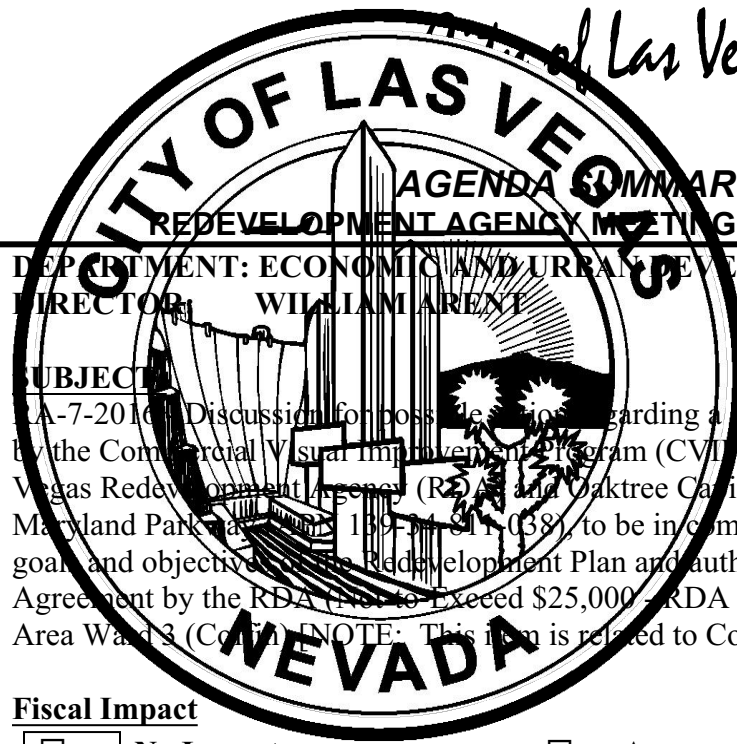

PURPOSE/BACKGROUND:

Oaktree Capital Series 3, LLC, will undertake exterior improvements to the property located at 420 South Maryland Parkway (APN 139-34-811-038) that include major rehabilitation of a dilapidated, vandalized apartment complex and conversion into live/work units. Exterior improvements will include new lighting, irrigation system for and landscaping of property, stone work, new exterior doors and windows, plaster repair, concrete and metal work, painting, signage and security features.

REDEVELOPMENT AGENCY MEETING OF: SEPTEMBER 7, 2016

Minutes:

BILL ARENT, Economic and Urban Development Director, was joined by ADAM FOULAD, Manager of Oaktree Capital Series 3, LLC. MR. ARENT explained that this item involves a request for funding through the CVIP program. He described the project and the extent of the exterior improvements, as outlined in the Subject and Purpose/Background sections, adding that the applicant intends to make an investment of approximately \$290,000, which qualifies for funding in an amount not to exceed \$25,000.

MR. FOULAD stated that through CVIP assistance he received last year, he was able to successfully develop another project. This application is for another live/work project. He showed PowerPoint slides depicting the current building status and conceptual improvements, and these were submitted as backup documentation. He indicated to CHAIR GOODMAN that his previous project was completed in June of 2015.

MEMBER ROSS said that exciting revitalization is occurring in the area, and he confirmed with MR. FOULAD that there will be a total of seven complete new mixed-use units.

MEMBER COFFIN mentioned some of the exciting businesses and centers that are coming into the area.
