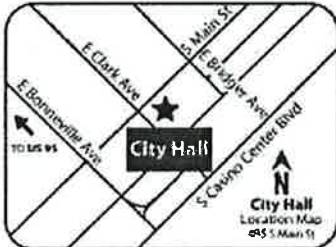

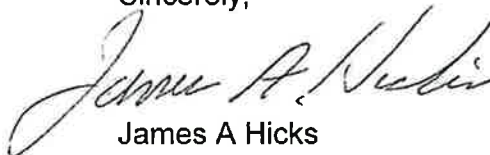

I own the property at 515 South 8th, located next door to the above applicant. I strongly oppose these proposed changes for the following reasons:

1. **Zon-64861** — The current buildings are already a hodge-podge, constructed years ago on the property line without proper permits, and to grant this variance would be to reward past transgressions. In addition, to change from Professional Office to Medium Density Residential would be a step backwards, as this neighborhood, which once was single-family homes, has been steadily moving forward to esthetically pleasing office spaces, which have helped preserve the historic quality, texture, and stature of this district. **Multiple density dwellings would detract and degrade this environment.**
2. **Var-64862** — **To allow significantly more narrow setbacks all around would increase the sprawl of this property and further encroach upon nearby neighbors.**
3. **Var-64864** — To reduce the number of parking spaces required on the property will undeniably result in even more parking congestion along the street. In addition, though parking spaces in front of offices are always full during the daytime, at least it clears out by late afternoon. **This variance would most certainly add to round-the-clock parking in front of my and adjacent property.**

In my opinion, the Special Planning Commission should deny these requests for the burden they would place on property owners along this street and the degradation of the neighborhood that would certainly result from their implementation.

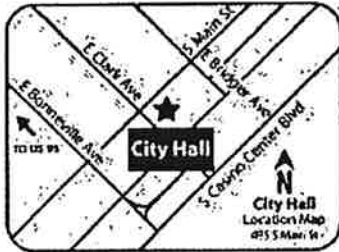

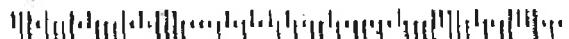

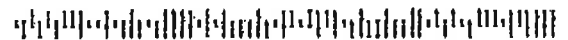
