3 AN ORDINANCE TO ADOPT THE 2018 EDITION OF THE UNIFORM PLUMBING CODE,
4 TOGETHER WITH AMENDMENTS THERETO, AND TO PROVIDE FOR OTHER RELATED
MATTERS.

Summary: Adopts the 2018 Edition of the
Uniform Plumbing Code, together with
amendments thereto.

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
8 FOLLOWS:

9 SECTION 1: Title 16, Chapter 28, Section 10, of the Municipal Code of the City of Las
10 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11 **16.28.010:** Those certain documents, copies of each being on file in the Office of the City Clerk, and
12 designated as follows, are adopted by reference and made a part of this Code, to the same effect as if set out
13 herein in full:

14 (A) Uniform Plumbing Code, [2012] 2018 Edition, including its Standards and
15 Appendices, except as otherwise indicated, designated as Part 1 of this Chapter; and

16 (B) A document entitled "Southern Nevada Amendments to the [2012] 2018 Uniform
17 Plumbing Code," adding to, deleting from and amending the Uniform Plumbing Code, [2012] 2018 Edition,
18 designated as Part 2 of this Chapter.

19 SECTION 2: The document entitled "Southern Nevada Amendments to the 2018 Uniform
20 Plumbing Code" is attached hereto.

21 SECTION 3: Ordinance No. 6355, the "Uniform Plumbing Code, 2012 Edition," and the
22 "Southern Nevada Amendments to the 2012 Uniform Plumbing Code," as amended, are hereby repealed in
23 their entirety.

24 SECTION 4: This Ordinance shall be effective as of February 4, 2019.

25 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
26 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by

1 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
2 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
3 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
4 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
5 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

6 SECTION 6: Whenever in this ordinance any act is prohibited or is made or declared to
7 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required
8 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of
9 such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon
10 conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of
11 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation
12 of this ordinance shall constitute a separate offense.

13 SECTION 7: All ordinances or parts of ordinances or sections, subsections, phrases,
14 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
15 Edition, in conflict herewith are hereby repealed.
