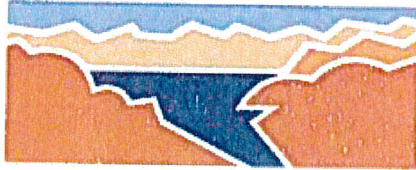

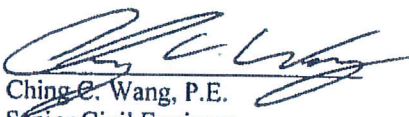
District concurs with acceptance of this Technical Drainage Study by City of Las Vegas Department of Public Works.

Subject: Skye Canyon Detention Basin 1 - Substantial Completion

Marc,

Based on field observation and testing results SHG has concluded that Skye Canyon Detention Basin 1 is Substantially Complete. The following major detention basin components have been determined to be in place and operational:

- Detention/Storage Volume
- Soil Cement Lining
- Inflow Channels
- Primary Outlet Structure and Outfall Pipe
- PMF Overflow Spillway

As a result of these facilities being operational, the basin now provides 100-year flood protection to downstream properties in accordance with the City of Las Vegas approved studies and plans. Therefore, as of 09/05/2017, Skye Canyon Detention Basin 1 meets the requirements for Substantial Completion.

Miscellaneous ancillary improvements are still being completed at the site (fencing, channel appurtenances, depth gauges, etc.), however these improvements do not impact downstream flood protection, and they will be completed prior to request for release of improvement bond.
