In an effort to increase administrative efficiency, the City of Las Vegas Public Works will be requiring all soils report, drainage study and traffic impact analysis submittals to be accompanied by an electronic copy of the submittal. Electronic documents must be submitted with one original hard copy of the study. Electronic documents should be on a universal computer-readable digital output replicating your submittal to be used for archival or display purposes. This may be more than one file if necessary. An Indexed Portable Document Format (PDF) or Print Ready CAD file formats with a minimum of 300dpi are the desired formats, but provided it is a high quality digitized replication of the submittal, other formats may be acceptable. If figures are in color, they must be scanned in color and saved as a separate file. The new submittal requirements will become effective on July 1, 2011. If there are any questions regarding these new requirements, please contact Robert Welch in the Flood Section at (702) 229-2177 or Rick Schroder in Traffic Engineering at (702) 229-6327.

NOTE: This drainage study assumes that the project will be constructed in one phase. If improvement plans are submitted to break the project into separate phases, a drainage study update will be required for each phase addressing the interim condition.

NOTE: Please be advised that all land surface area disturbances over 1 acre or any area adjacent to a water way must submit to the *Nevada Division of Environmental Protection* a "Notice of Intent" to discharge that certifies a stormwater pollution prevention plan has been developed and is maintained on site; for inclusion in the Stormwater General Permit No. NVR100000. A phased construction unit in a contiguous subdivision is considered under construction until all stripped or disturbed surface areas have been covered by paving, building construction or planting. NOTE: Any future changes to the proposed design (or design assumptions) as outlined in the approved drainage study and attached preliminary grading plan which affect drainage must be addressed in a Drainage Study Amendment and accepted by the *City of Las Vegas Flood Control Section*. Additionally, conditional acceptance of a drainage study is valid for a period of one (1) year. If the proposed construction has not been completed in that time period, the *City of Las Vegas* reserves the right to require additional conditions and/or submission and acceptance of a complete drainage study update prior to further construction of a project.

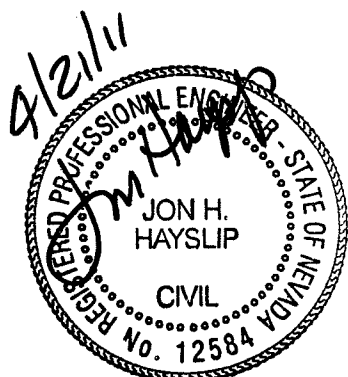

Dear Mr. Sung:

The Technical Drainage Study Update #5 for Sky View Pines was conditionally approved by the City of Las Vegas on January 3, 2011. Since the last approval of this project, the site plan has been revised per the owners request to add an onsite retaining wall adjacent to the access sidewalk near the drive aisle entrance and minor detail revisions.

Site Revisions

The proposed site revision for the onsite retaining wall is shown in red on Sheet GR1 and corresponding Detail D on sheet DT1. The addition on the onsite retaining wall allows for better use of the area east of Building 1. Also, Details A and B on Sheet DT1 have been revised to show the distance between the CMU wall along the Owens Avenue back of sidewalk and the top of the landscape drainage swale varies.

The original drainage system and storm drain remains unchanged. No modifications to the drainage basins or drainage patterns will result as these modifications.

A copy of the grading plan and detail sheet are included in the map pocket at the back of this Study.
