1. A Letter of Map Revision (LOMR-F) must be obtained from FEMA after the completion of any project within a FEMA Special Flood Hazard Area, Flood Zone "AE". The bonded improvements shall include a line item of **\$50,000.00** for the LOMR-F. The bonded improvements will not be released until the LOMR-F is obtained from FEMA and filed with the City of Las Vegas.
2. Revise the BFE on the Grading Plan and Detail Sheet to reflect the 1% Annual Chance Flood Elevation of 2324.7 feet per FEMA LOMR Case No.: 16-09-3077A for Lot C.

The Engineer is to provide addresses for each building in a FEMA Flood Hazard Zone prior to obtaining a grading permit. This information is necessary to insure that the FEMA elevation certificates are provided for each address prior to the issuance of the building permits. Updated FEMA elevation certificates are required after the finish floors are complete prior to scheduling a framing inspection. The as-built FEMA elevation certificates are required at the completion of construction prior to requesting the certificate of occupancy.

- NOTE:** This site is located in a **FEMA Zone AE**. Clark County Regional Flood Control District (CCRFCD) review and approval is required prior to recordation of final map or issuance of building/grading permits. The Engineer must send a copy of the report to the CCRFCD for review. **The developer/engineer must also obtain a Letter of Map Revision (LOMR) using the approved drainage study as technical support to inform FEMA of the modifications within the flood zone. The approved LOMR must be submitted to the City of Las Vegas prior to the release of the bond.** FEMA Elevation Certificates, showing as-built finish floor elevations, must be completed for each building in the FEMA AE Zone. The certificate must be submitted to the *City of Las Vegas Flood Control Section* prior to scheduling a framing inspection.
- NOTE:** Any future changes to the proposed design (or design assumptions) as outlined in the approved drainage study and attached preliminary grading plan which affect drainage must be addressed in a Drainage Study Update and accepted by the *City of Las Vegas Flood Control Section*. Additionally, conditional acceptance of a drainage study is valid for a period of one (1) year. If the proposed construction has not been completed in that time period, the *City of Las Vegas* reserves the right to require additional conditions and/or submission and acceptance of a complete drainage study update prior to further construction of a project.
- NOTE:** Please be advised that all land surface area disturbances over 1 acre or any area adjacent to a water way must submit to the *Nevada Division of Environmental Protection* a "Notice of Intent" to discharge that certifies a stormwater pollution prevention plan has been developed and is maintained on site; for inclusion in the Stormwater General Permit No. NVR100000. A phased construction unit in a contiguous subdivision is considered under construction until all stripped or disturbed surface areas have been covered by paving, building construction or planting. 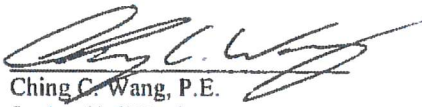
District concurs with acceptance of this Technical Drainage Study by City of Las Vegas Department of Public Works.

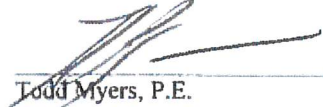

Therefore, consultant should be advised that this acceptance does not serve to amend the FIRM or remove the SFHA.
