Prior to this item, MAYOR GOODMAN addressed the Council stating one year ago, on Wednesday, March 18, 2020, she stood before the Council to express her deep concerns about completely shutting down Las Vegas.

This decision by one individual, which required no vote by the Nevada Legislature or any other elected body, promised to cause undue hardship to hundreds of thousands of Nevadans. Her plea at the time was to take a more nuanced approach and enact safety precautions that would enable Las Vegas to continue to function. A full year later, some states which took this moderate approach, like more populous Florida and Texas for example, actually realized a lower death count per 100,000 residents than did some states with prolonged, total shutdowns like Michigan, New York and Nevada, according to Statista.com, March 8, 2021. Nevadans, many of whom still have not been able to get through to the State's unemployment office to receive the funds owed to them, have suffered tremendously. Many of the small businesses, and even some larger ones, were forced to close their doors, and school children have suffered immeasurably. As she pleaded for moderation, some individuals, especially certain newscasters, took great issue with her stance to enact reasonable safety precautions and entrust Nevadans and tourists to make responsible decisions.

The Mayor recalled what she said on March 18, 2020 in response to the Governor's shutdown directive where she asserted that the city could not survive any total shutdown of the economy, and she asked the Governor to shorten the projected shutdown. A full year later, businesses are still only operating at 50 percent capacity, up from a bizarre 35 percent that was in effect until three days ago. Children are only now returning to public school, and only Kindergarten through Fifth Grade are in-person full time. Tens of thousands of students have missed out on graduations, proms, extracurricular activities, sports, and scholarships, not to mention a year's worth of invaluable, in-person instruction. In March of 2020, when the Governor announced in a call that he was shutting down the schools, the Mayor pleaded with him to implement safety measures and mandatory temperature checks instead of shutting down, and she was harshly told he was not seeking input. She said while all deaths are beyond heart-breaking, the data shows no consistent correlation in death rates between states with prolonged, complete shutdowns like Nevada and those that adopted more moderate safety precautions. Additionally, the four states with the highest death rates were states that adopted stringent shutdown policies. MAYOR GOODMAN wondered why masks and social distancing are sufficient now to slow the spread of this virus, but those practices were not sufficient a year ago. She also questioned the rationale for continuing at 50 percent capacity limits while there are other precautions like mask mandates in place, in addition to increasing the number of vaccinations.

MAYOR GOODMAN said America is the land of the free, but Americans in some states have been forced to subjugate their freedoms to the will of a single individual, seemingly in perpetuity. She called for a return to personal responsibility and personal liberty, and said those who do not want to go out to public places are not forced to do so, just as those who do not want the vaccine are not forced to get it. Masks, distancing, and frequent hand-washing and sanitation are reasonable measures that health officials assure will make a difference. The Mayor said science has not proven that complete shutdowns accomplished any more than more moderate, reasonable precautions. Nevadans and Americans are smart enough to understand what is at stake and make appropriate choices for themselves and their families. As one caller to her office recently expressed, it is beyond sad and concerning to see Lady Liberty on the Las Vegas Strip wearing a mask, which the Mayor opined to be the antithesis of what she and America represent, personal freedom. She reiterated the remarks she made a year ago, which is that the City of Las Vegas will seek ways for people and businesses to advocate for their own lives, make their own choices, create and follow their own destinies, and live being assured they have the right to do so in dignity, earning a livelihood, providing for their families and even helping others to enjoy those same rights and dignities.

Minutes:

Using a PowerPoint presentation, a copy of which was submitted and is attached as backup, CITY MANAGER JORGE CERVANTES stated he was bringing before the Council a new two-year collective bargaining agreement with the Las Vegas Police Protective Association (LVPPA). The agreement covers Fiscal Year 2021, the current fiscal year, and Fiscal Year 2022, which will start July 1, 2021. He stated the LVPPA represents approximately 110 Marshals, who provide front-line security at the community centers, parks, municipal courts and street right-of-ways, and that the fiscal impact of the agreement over two years is \$379,339.

VINCE ZAMORA, Human Resources Director, reiterated this agreement covers approximately 109 members for Fiscal Years 2021 and 2022. Negotiations started on January 7, 2021, and an agreement was reached after the third meeting, with negotiations concluding on February 17, 2021. He explained with regard to wages, all members will receive a \$1,325 one-time cash payment. In year two, Tier 1 Marshals will receive a 1.75 percent Cost of Living Allowance (COLA), and Tier 2 Marshals will receive a two percent COLA. Other economic provisions include increasing the sick leave bonus eligibility period and moving Tier 2 Sergeants to the Tier 1 pay scale. In year two, Step 1 of the Tier 2 Marshal pay scale will be eliminated, which will provide a higher starting salary range. Additionally, two steps will be added to the Tier 2 Marshal pay scale, which will provide greater salary potential and brings the City closer in parity with other agencies. The total fiscal impact of this item is \$379,339.

MR. ZAMORA recognized the members of the LVPPA, the City of Las Vegas' negotiating teams and every Marshal who serves the community.

MAYOR GOODMAN echoed the praise given and thanked the Marshals and all who were involved in the negotiations.

MAYOR GOODMAN declared the Public Hearing open for Items 43-43d.

GEORGE ROGERS, Architect, appeared representing the applicant. He explained this is an equipment dealership for equipment that would be used by small contractors or landscapers. He noted a neighborhood meeting was held in December. Staff from COUNCILMAN CREAR'S office and one other individual were in attendance, and there were no negative comments.

PETER LOWENSTEIN, Deputy Planning Director, reported staff found the proposed land use designation and zoning to be harmonious and compatible with adjacent properties to the east and the west, concurred with the provided parking study and supported the alternative parking standard. Additionally, the requested waiver to not orient the building to the corner will improve onsite maneuvering of semi-trucks and heavy equipment, thereby lessening the impact on neighboring properties. As such, staff recommended approval of all applications.

At the Mayor's request, MR. ROGERS explained the ingress/egress of the property, noting there is one driveway on Bonanza Road and one on Martin Luther King Boulevard, which has a restriction due to the center median. MR. LOWENSTEIN added there are medians on both of those roadways, making the ingress/egress right in, right out at both points. With Martin Luther King Boulevard becoming extremely busy, MAYOR GOODMAN expressed concerns with traffic becoming backed up.

COUNCILMAN CREAR said the applicant has been diligent in working with his office and the community, which he appreciates. He recognized this to be a part of major reconstruction along this thoroughfare, but shared the Mayor's concerns with regard to traffic on Martin Luther King Boulevard and drivers trying to access Interstate 15 and U.S. Highway 95. He asked MR. ROGERS, in his professional opinion, if what was being proposed would further hinder traffic.

MR. ROGERS explained this dealership is a new equipment dealership, and there is one similar in North Las Vegas, which was cited in the traffic analysis submitted with the application. Trucks will not be delivering used equipment or equipment for maintenance at this facility. The larger building exists on the site to assemble the equipment being sold, and they do not expect daily truck deliveries besides stocking the site during the opening phase. He offered to schedule those deliveries during off traffic hours to alleviate some of the traffic concerns.

COUNCILMAN CREAR commented just having the facility at this location would create more traffic, whether that be equipment or automobiles. MR. LOWENSTEIN pointed out there is a condition of approval on the Site Development Review stating all trucks accessing the site, such as those delivering or removing proposed construction equipment, shall access the site only via Bonanza Road unless otherwise approved by the City Traffic Engineer.

COUNCILMAN CREAR asked if it would be too prohibitive to the operation if the only ingress was Bonanza Road and the only egress was Martin Luther King Boulevard. MR. ROGERS did not believe it would be prohibitive, but added there would only be a handful of employees on site, so they do not anticipate a lot of vehicular or pedestrian traffic. He thought it fair to add a condition regarding the ingress/egress. COUNCILMAN CREAR wished to add a condition regarding the ingress/egress, along with a one-year administrative review to revisit if necessary. MR. ROGERS was in agreement.

MAYOR GOODMAN expressed her concern with the wide turn radius needed by any flat beds accessing the property to deliver equipment. MR. ROGERS confirmed flatbeds would be used to deliver the equipment onto the property, but noted those vehicles would not pass adjacent to the Bonanza Road or the Martin Luther King Boulevard frontage. Unloading would take place on the west and south sides of the building, and then the vehicles would exit onto Martin Luther King Boulevard, given the Councilman's added condition. COUNCILMAN CREAR thought accessing the property off of Bonanza Road was appropriate and would create an easier flow.

LANDON CHRISTOPHERSON appeared on behalf of the applicant/owner. He stated the applicant's original intent was an extension of Rainbow Academy, but with the State and Clark County School District changes, that is no longer feasible, and staff developed a plan to utilize the property as a transition. The number of units was reduced from 25 to 22 due to some concerns. He stated the applicant has tried to purchase the adjacent single-family residential parcel over the past several years, but the parties are not in agreement, so landscaping has been provided as a buffer to alleviate the majority of their concerns. MR. CHRISTOPHERSON noted these will be for sale, attached single-family units with approximately 1,377 square feet, three bedrooms, two-and-one-half baths and a two car garage. To alleviate any public safety concerns, the required radius has been provided for fire truck access throughout the property.

MR. CHRISTOPHERSON informed MAYOR GOODMAN the units are two stories and that there will be two entrances off of Hart Avenue, with no entrance off of Lake Mead Boulevard or Concord Street. He also indicated one neighborhood meeting was held.

PETER LOWENSTEIN, Deputy Planning Director, asked if the reduction to 22 units had been submitted to staff, to which MR. CHRISTOPHERSON stated it was submitted before the Planning Commission meeting. MR. LOWENSTEIN continued with his report, stating while the approval of the requested General Plan Amendment and Rezoning would support objectives of the West Las Vegas Plan, if development of the site fell through, the block's land use designations and zoning districts would be inconsistent and leave one single-family detached home surrounded by higher density residential development. No evidence of a unique or extraordinary circumstance was presented to support the Variance requests and staff recommended denial. As the Site Development Plan Review is dependent upon the approval of the Variance, staff could not support that application either. As such, staff recommended denial of all applications.

47. 20-0378-MOD1 - MAJOR MODIFICATION - PUBLIC HEARING - APPLICANT/OWNER: THE HOWARD HUGHES COMPANY, LLC - For possible action on a Land Use Entitlement project request for a Major Modification of the approved Summerlin Development Standards TO MODIFY THE GENERAL RESIDENTIAL SETBACK STANDARDS (APNs Multiple), P-C (Planned Community) Zone, Ward 2 (Seaman) and Ward 4 (Anthony). Staff recommends DENIAL. The Planning Commission (7-0 vote) recommends APPROVAL.

Minutes:

MAYOR GOODMAN declared the Public Hearing open.

ATTORNEY STEPHANIE ALLEN appeared on behalf of the applicant. She explained this request is to update and clean up Summerlin's design standards as the market and product types have changed. The clean-up item relates to how corner setbacks are measured to make them consistent with the City. The second request is to allow entry portals, which are used for product types where the front doors are on the sides of the homes. Summerlin believes this to be an upgrade and has been asking its builders to use these architectural elements so the front door can be seen from the streetscape easier. MS. ALLEN displayed photographs of homes located outside of Summerlin where the door is on the side, noting one could not tell where the door was located if it were not for the pathway leading to it. She also displayed photographs of entry portals similar to what is being proposed that include architectural elements with a stucco area and a fence to identify which side of the house the front door is located. She noted in this instance, a zero-foot setback is required on a small portion of the encroachment, not the entire length of the property line. She indicated the language in the design standards before the Council addresses several of these components. MS. ALLEN read proposed added language to address staff's concerns relating to property lines and drainage, which was approved by the Planning Commission. She thought this would incorporate the intent of what Summerlin is looking to do, improve the street scene for some of their developments and allow their builders' products to evolve in the Summerlin community.

MAYOR GOODMAN asked staff about wall ownership and the placement of tree plantings. PETER LOWENSTEIN, Deputy Planning Director, explained what is being proposed does not address the planting of landscape materials on the lot, and that typically the property line is down the center of the wall, so any damage would become a civil matter. The Master and/or Sub Association CC&Rs (Covenants, Conditions & Restrictions) may address the type of landscaping more specifically, but this amendment is specific to the architectural component of the home. The Mayor confirmed the City holds no liability with regard to the wall, and MR. LOWENSTEIN stated the wall will be permitted, inspected and finalized through the building permit process, and at that point, it will have met all City and Residential Building Code standards.

To make a clear record, MR. LOWENSTEIN read language into the record mirroring what was presented by MS. ALLEN, which he indicated could be found within the supplemental materials. He went on to state that staff found, while the amended language alleviates previous concerns regarding how corner setbacks are measured, the zero-foot side yard setback for entry portals is not consistent with the intent of the single-family residence design principles, and staff therefore, recommended denial of the requested modification. He indicated there was not a lot of deliberation on this item at the Planning Commission meeting and that they recommended approval.

MAYOR GOODMAN declared the Public Hearing closed.

REPORTS AND PRESENTATIONS

48. Report by School Associate Superintendents on the current educational operations in schools within the Clark County School District (CCSD) in the City of Las Vegas - All Wards

Minutes:

DR. TAMMY MALICH, Director of Youth Development and Social Innovation, stated the quarterly update would be presented by LORNA JAMES-CERVANTES, School Associate Superintendent, Clark County School District (CCSD), which will fulfill the current statutory requirement created by Assembly Bill 469. DR. MALICH distributed material, which was submitted and is attached as backup.

MS. JAMES-CERVANTES stated the school year began with full distance education, and currently they are beginning to move towards opening schools in a hybrid learning model. Parents and staff were surveyed and asked to select which cohort they would like their child to attend (hybrid model or maintain full distance learning).

Teachers were given the opportunity to provide input as well, as to whether they would like to return to in-person teaching or remain teaching in a distance learning model. A hybrid implementation guide release was created and has been updated several times to include transition timelines, implementation checklists, health and safety protocols, facility preparation and maintenance, school operations, food service, transportation, technology, athletics, human resources and communications.

MS. JAMES-CERVANTES stated one of the biggest challenges with distance learning last fall was connectivity, but since meeting with the City last, 100 percent of the students and families who had technology concerns have been addressed by providing the necessary services and technology. She noted this was due in large part to different Councilmembers and the City's help. She commented that the teachers have adapted and are doing an outstanding job of educating the students during this difficult time through distance education and transitioning back to the hybrid model for elementary teachers. They are continuing to reach out to those students who need assistance in small group instruction and also providing one-on-one and group assistance to the students.

MS. JAMES-CERVANTES stated the last time CCSD was before the Council, they were asked about enrollment concerns in the different Wards and if there were particular student groups or populations that were most challenged. She provided a spreadsheet showing percentages for each student group broken down by Ward. She noted it was interesting that they did not see drops in enrollment in one particular group, and that it varied from Ward to Ward.

Speaking to the reopening timeline, MS. JAMES-CERVANTES stated all Pre-K through 3rd Grade students were offered to return in a hybrid instructional model on March 1, 2021. Children have been added to this learning model as additional requests have come in by parents, even if that is not what the parents originally indicated they wanted. On March 22, 2021, Grades 6, 9 and 12 will be returning to face-to-face instruction under the same model. On April 6, 2021, Grades 7, 8, 10 and 11 can return, and Pre-K through 5th Grade can return to five days a week either face-to-face instruction or distance learning model, depending on what their parents selected. She thought it important to point out that one of the reasons why they are using the hybrid approach is because the state reopening requirements require a 21-day hybrid learning model first to show on a small group rollout that things are working well and all of the safety expectations and requirements are in place before moving into the full in-person learning model.

With regard to mediation plans to address learning gaps, they have been working throughout the year on this to ensure all students have the opportunity they need through distance learning. Teachers provided small group instruction so students could receive additional assistance. Additionally, the Zoom reading and learning centers continued to operate in a distance learning model. This will transition to in-person small group instruction as they move into the hybrid learning model. Throughout this time, they have also used a number of online programs and web-based programs to assist students such as Khan Academy, Smarty Ants Achieve 3000 and others to help engage students on their individual levels. Measure of Academic Progress (MAP) testing has also been implemented throughout the year. Another big concern has been with the emotional and mental health of students. The number of student suicides has doubled since the prior year, and CCSD invested in GoGuardian Beacon alerts to help identify students who need assistance. Currently, CCSD police, the Las Vegas Metropolitan Police Department (LVMPD) and other police forces are working together to perform welfare checks on students in crisis and to help connect them to school and community resources.

Using a slide from the presentation material, MS. JAMES-CERVANTES went on to explain what a hybrid instructional model looks like. Due to the fact that some teachers are teaching in person and some online at the same time, this model has been implemented in several ways. She noted the difference between the elementary, middle and high school models is that elementary students will have in-person learning all day, and middle and high school students will have in-person classes in the morning for the first two periods of the day, followed by a transition period to home, and then online classes in the afternoon.

In closing, MS. JAMES-CERVANTES assured the Council that the safety and well-being of students and staff is a major priority of CCSD. They have continued comprehensive health and safety procedures, which are outlined in the Hybrid Instructional Model Implementation Guide, which she said is available online in both English and Spanish at reconnect.ccsd.net. Schools are undertaking daily safety protocols to ensure everyone remains safe and healthy while at school. Every employee is screened daily, which includes taking temperatures and self-reporting of any COVID-19 symptoms.

With regard to expectations and plans if CCSD enrollment is lower for the coming 2021-2022 school year, she reiterated CCSD is funded based on student enrollment, but they will make any necessary adjustments based on

that enrollment at the beginning of the year if necessary. However, in looking ahead, they conservatively projected the school enrollment for next year to help mitigate any decreases in enrollment. They anticipate a number of students returning to CCSD from charter and private schools once they reopen, which they are already seeing.

MS. JAMES-CERVANTES stated she was also asked to address any accommodations regarding sensitivity to equity, diversity and inclusion within the schools. Equity and opportunities are a priority, and they have goals set in their Focus 2024 plan that are specific to equitable access for all students in education, and they created systems to ensure equitable and instructional opportunities in advance coursework through implementation of course enrollment guides that are being used across all CCSD schools. There will be vertical alignment, professional learning groups among principals and data desegregation to ensure a constant focus on equitable opportunities for all students. Grading policies are currently being reviewed and updated to ensure they are equitable for all students. They are also working with the Student Services Division to closely track student discipline and reduce exclusionary disciplinary practices. Human Resources is diversifying teacher recruitment at historically black-serving or Hispanic-serving institutions to help diversify their teaching staff as well. They have broadened the pipeline for support professionals to attain the coursework necessary to earn their teaching credentials and for teachers to earn their administrative endorsements. They are also expanding CTA (Certified Travel Associate) programs to include teacher preparation programs beginning in high school in an effort to grow their own high quality teachers for CCSD.

As far as Legislative intents, MS. JAMES-CERVANTES said she included a copy of the CCSD legislative priorities this year in the backup material, and noted they center around internet connectivity, staffing efficiencies, school funding, school safety and mental health and improved learning conditions for all students. She appreciated the opportunity to share what is transpiring in CCSD and recognized COUNCILMAN KNUDSEN, who has been working to expand artwork in the schools.

MAYOR GOODMAN thanked MS. JAMES-CERVANTES for a very informative report. COUNCILMAN KNUDSEN appreciated the presentation, which addressed all of the questions he asked the last time CCSD was before the Council. He also stated when he hit roadblocks with CCSD, he called MS. JAMES-CERVANTES, and she was always willing to offer her guidance and assistance, which allows for him to be successful in working with the school district. He acknowledged how difficult it must be to try to navigate the school district during this time and recognizes how much she and the teachers care about the students. He noted work he is doing with the Associate Superintendent includes looking at Wasden and Rex Bell Elementary Schools and integrating the University of Nevada, Las Vegas schools of medicine, nursing and liberal arts. They also have private sector partners that will be coming forward working with the Mayors Fund for Life. He said the focus is on the students and teachers and making sure they are prepared to deal with whatever lies ahead. He has heard repeatedly that teachers are struggling with their own stress associated with students who have extreme trauma in their lives, which he imagined to be exacerbated during the pandemic over the past year. As a city, he fully supports the full reopening of schools with children going back to school and being prepared for such to ensure that students are successful.

MAYOR GOODMAN said it sounded as though the possibility of a magnet school at Wasden Elementary School was on pause, but that some headway was made as to curricular emphasis. COUNCILMAN KNUDSEN confirmed, adding he would continue to work with CCSD.

COUNCILWOMAN DIAZ asked what the decline in enrollment was being attributed to (i.e., transfers to other educational options, moves out of state, etc.). MS. JAMES-CERVANTES said in speaking with principals who have made multiple calls to families, a large number of students transferred to private or parochial schools that offered full, in-person learning. However, many of those parents are already saying they will return once CCSD schools are open. Also, in working with the principal at Valley High School, she said many students and families reported that they have had to move in with other family members, some of which are out of state, because parents are out of work. Additionally, several high school students are working to help support their families, and have been offered senior load exemptions so they can continue to do so. She offered to obtain more in-depth details from their student records department as to where some of these students have gone.

COUNCILWOMAN DIAZ felt it was prudent to wait until there was a forecast for the next school year so a comparison can be made between the registration numbers now and the next school year. She then spoke of being culturally sensitive and that some communities are finding it very difficult to schedule their vaccines due to their unpredictable work schedule and because they do not know how to navigate the technology. As such, she asked what efforts CCSD will be embarking on in terms of assisting parents with the registration process. MS.

JAMES-CERVANTES explained they will continue to have individual schools open where staff can sit side-by-side with parents and assist with such things as password recovery and enrollment. They also have back to school fairs and a family support unit that takes an RV out into the community to provide assistance. As soon as the health district can support it, CCSD will partner with them in their efforts to make sure students have all of their regular required vaccines in order to be enrolled in school. It is their top priority to have students enrolled, and if any new efforts or ideas arise, she will share them with the Councilmembers. COUNCILWOMAN DIAZ thought there was some appetite by the Council in supporting those efforts.

COUNCILWOMAN DIAZ praised teachers and acknowledged their struggles in teaching the hybrid model. She then asked if CCSD is entertaining summer learning opportunities to address the academic deficit. MS. JAMES-CERVANTES explained that there are plans in the works for summer learning opportunities as well as bridge programs. The final plans have not been shared with the Board yet, but planning is currently underway and will be shared publicly once they are finalized. MAYOR GOODMAN added that the federal government has set aside funds specifically for summer learning.

COUNCILWOMAN DIAZ thanked MS. JAMES-CERVANTES for acknowledging the need for diverse administration, as she believes this provides a better opportunity to connect with the community. Lastly, she asked if Grades 6 through 12 will be coming back five days a week. MS. JAMES-CERVANTES said that was discussed, but since there are only about seven weeks remaining in the school year, the plan is to bring them back now under the hybrid model, and hopefully to full-time, in-person classes the next school year. The Councilwoman echoed COUNCILMAN KNUDSEN'S comments about supporting student learning and hoped they can all work collaboratively. MS. JAMES-CERVANTES stated anyone could reach out to her directly for assistance if needed.

Noting that private schools remained open during the pandemic, COUNCILWOMAN FIORE said the public school system failed children, pointing out that in some instances, school is the only safety zone for children who are being abused. She thought a lot of lives could have been saved, abuse prevented and trauma avoided had the public schools remained open. MS. JAMES-CERVANTES thanked the Councilwoman for her comments.

MAYOR GOODMAN asked about the shortage of teachers. MS. JAMES-CERVANTES estimated the shortage to be approximately 400, but said she could get back to her with an exact number. She added if there were any substitute teachers or teachers that want to come back to work, they are needed and should apply at ccscd.net or call their Human Resources Department. She confirmed for the Mayor that they went from approximately 320,000 students to about 317,000.

COUNCILWOMAN DIAZ felt the ceremonial portion of the Council agenda was instrumental in recognizing the many heroes in the community, and asked if that component could be brought back in a safe manner.

In looking at other agencies, MAYOR GOODMAN noted due to the pandemic, such has been very limited, if at all, because of the ability to house and seat people who would be a part of those celebrations. CITY MANAGER JORGE CERVANTES stated such discussions have taken place, but there is still concern meeting the social distancing requirements and keeping in compliance with all directives. However, the Executive Team will revisit this topic to see if there is an opportunity to incorporate some smaller celebrations.

COUNCIL MEMBER RECOGNITION

52. Council Member Recognition: Comments made by individual City Council Members during this portion of the agenda will not be acted upon by the City Council unless that subject is on the agenda and scheduled for action.

Minutes:

COUNCILMEMBERS FIORE, SEAMAN, CREAR, DIAZ and KNUDSEN announced the various events taking place in their wards on various dates throughout the months of March and April. Some of the Councilmembers submitted flyers, which are attached as backup, regarding their events and points of interest.

COUNCILWOMAN FIORE highlighted MAYOR GOODMAN as part of Women's History Month. She briefly touched on where the Mayor was born, her schooling, meeting former Mayor OSCAR GOODMAN, moving from Philadelphia to Las Vegas, working to build the community, being the head of the Women's Division at the local Jewish Federation, and raising four children. Additionally, the Councilwoman pointed out the Mayor received her Master's Degree from the University of Nevada, Las Vegas and founded the Meadows School, Nevada's first nonprofit preparatory school for pre-K through 12th Grade, where she oversaw the day-to-day operations for 26 years without taking a salary. She retired in 2010 and was sworn in as Mayor in 2011. Combined, the Mayor and her predecessor, former Mayor OSCAR GOODMAN, will have served as Mayor of Las Vegas for 25 years. COUNCILWOMAN FIORE stated MAYOR GOODMAN continues to rebuild the city and champions the improvement of inner city schools. She also recognized the Mayor's birthday this month. MAYOR GOODMAN described the photos that were displayed.

MAYOR GOODMAN said people are ready to return to normalcy, and she encouraged those who want to get vaccinated to do so. She thanked various City departments for their hard work and efforts during these difficult times and announced the next City Council meeting would be April 7, 2021. Lastly, she wished all a Happy St. Patrick's Day.
