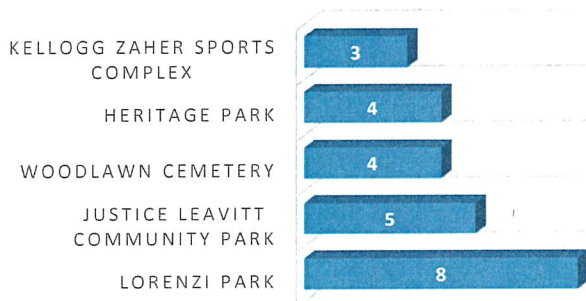

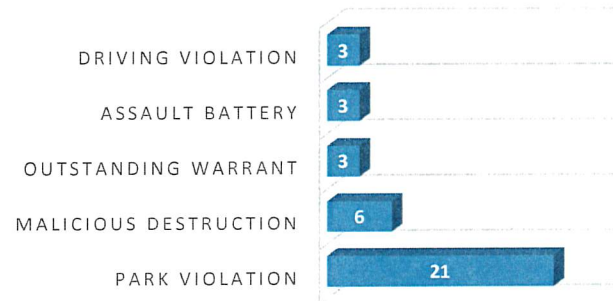
WILDLIFE VIOLATIONS
