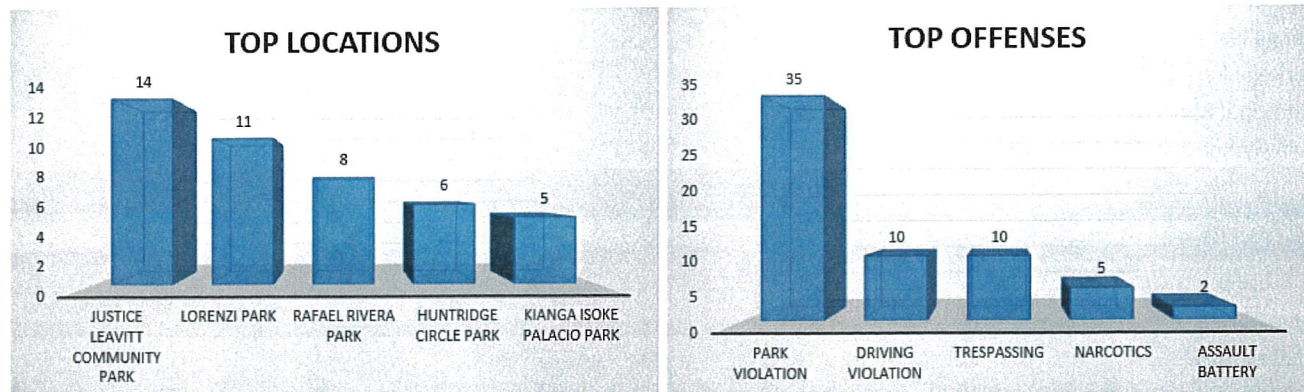

WILDLIFE VIOLATIONS

Zero feeding violations were reported in City of Las Vegas parks during February 2022.

TRENDS IN PARKS/FACILITIES

- 15 incident reports of graffiti/malicious destruction - about 18% of total park/facility reports
- 14 arrests/citations at Justice Leavitt Community Park – about 29% of narcotics/drug paraphernalia charges
- 52% of arrests/citations occurred in Ward 3
- 39% of arrests/citations occurred in Ward 5
