5. Discussion for possible action regarding a Facility Use Agreement between the City of Las Vegas Redevelopment Agency and the Dragone Creations USA, LLC (Dragone) for office space (Suite 130), located at 801 South Main Street, and known as the International Innovation Center @ Vegas 2 (The Herbert) - Redevelopment Area - Ward 3 (Diaz) [NOTE: This item is related to Council Item 13]

Minutes:

RYAN SMITH, Director of Economic and Urban Development, introduced DAMIAN LONG, Director of Creation for Dragone Creations USA, and then gave thanks to his staff member, RICH ATKINS, Development Officer, and IGELEKE CHRISLOVE, Deputy City Attorney, as well as NATALIE WAINWRIGHT, Commercial Broker with Logic Commercial Real Estate, for recommending to Logic Commercial to work with the City of Las Vegas.

MR. SMITH explained that the goal of international centers is to incubate innovative startups and create an entry point for companies looking to grow and expand within the City of Las Vegas, and the City chose The Herbert as its expansion location in order to attract more innovative and creative companies. Dragone will be looking into relocating its headquarters from Belgium to the City of Las Vegas in multiple phases and will eventually occupy approximately 30,000 square feet of space.

MR. SMITH highlighted the terms of the subject agreement, which includes payment of approximately \$3,500 monthly and to bring in about 10-15 employees initially.

MR. LONG said he has been with Dragone for 15 years and was born and raised in Las Vegas, so he is excited to be bringing the headquarters to Las Vegas, where they did their first show, A New Day, with CELINE DIONE. Unfortunately, the pandemic hindered their shows worldwide. However, they survived, and they are working on numerous productions for different parts of the world, such as in Vietnam, in Europe and in the Middle East. Their first goal is to bring their high-level team of production designers and core group to Las Vegas over a period of two years and to work with the City of Las Vegas in order to continue growing.

Given that the Cirque shows came out of Canada, CHAIR GOODMAN asked if there will be a relationship with Canada and Dragone as well. MR. LONG replied that their goal is to centralize all work in Las Vegas, even though they will have international productions. The Chair asked if public tours will be made available to give opportunities to learn about the company. MR. LONG said the company has a desire to help and work with the younger generations through the University of Nevada, Las Vegas, and the local entertainment industry. CHAIR GOODMAN said Las Vegas is a perfect location for the company because of the international airport and all the hotel rooms.

MEMBER CREAR was happy to see Dragone coming into the City of Las Vegas because it has transformed entertainment in Las Vegas and has produced amazing shows.

MEMBER DIAZ welcomed Dragone Creations to Ward 3 and hoped that they will save the best productions for Las Vegas. MR. LONG noted that Dragone's goal is to revolutionize entertainment in Las Vegas. He indicated to the Chair that they should be moving in sometime in March or April of 2022.
