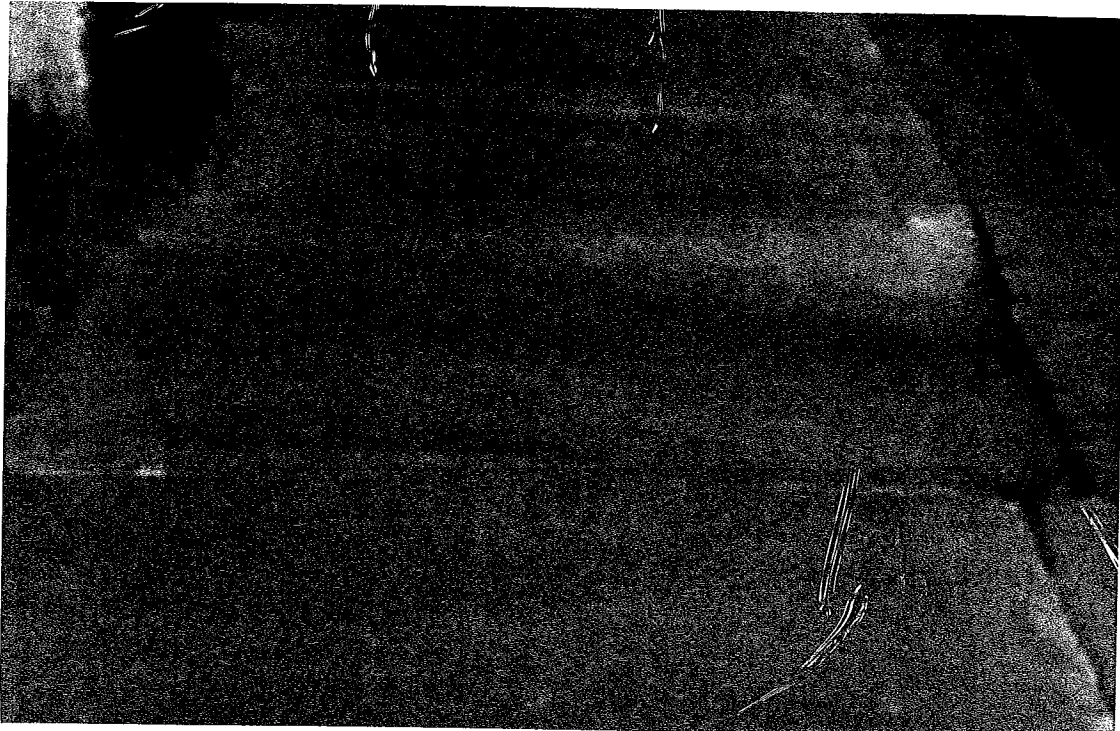




Senior Citizens Advisory Board Agenda
