The help button was helpful and just received an answer to my question and a link to the proper page.

The Doolittle community garden is getting it's paths weeded. The beds scheduled for rebuilding have not begun. The full time Master Gardener is helpful.

I've signed up for a couple of webinars. One next week on communities of excellence where Executive Director Stephanie Norling will share the details of the National Learning Collaborative and how to get involved. We will also have current and former Learning Collaborative participants available to answer your questions and talk about their own experiences.

Another webinar this summer (July 12th) is from the US Census bureau on "Your Community by the Numbers: Community Development"

The goal is to learn how to use data.census.gov to access the most current and relevant demographic, socioeconomic, and housing statistics about your community. During this training, you will learn about the American Community Survey (ACS) and other Census Bureau programs, geographies, and datasets available. This training is recommended for all data users.

Chair O'Rear-Cameron mentioned her concern regarding casinos and the care of seniors. I'm submitting a copy of Boyd Gaming's local "Young at Heart" rules and a list of Nevada Revised Statutes which deal with senior citizens. At a presentation on elder abuse three years ago at Doolittle Senior Center by someone from the Las Vegas Metropolitan Police Department ("Metro"), the officer was careful to warn his listeners that offering to help seniors but not following through was against the law. Is there an implied caring aspect in casinos who have special marketing to seniors? I don't know. Our laws seem to be a balance of freedom and protection but perhaps leaning more towards freedom than protection. What do you think?

The Nevada Gaming Control Board (the Board) requires "each licensee that engages in the issuance of credit, check cashing, or the direct mail marketing of gaming opportunities, to implement a program containing the elements described below, as appropriate, that allows patrons to self-limit their access to the issuance of credit, check cashing, or direct mail marketing by that licensee."¹ The challenge to this, as Phillip Ryan's letter to the Board in April of 2013, is that self-limiting has to be done with every single licensee. There is no "integrated regulatory regime into state compacts which will ensure that all responsible gaming (money limits) are centrally administered." In the bad old days, even 10 years ago, one casino downtown had a bank set up shop inside the casino. Being a bank, they were not subject to the rules of the Board, and did not care if you had "self-limited" yourself. There needs to be one place to self limit and that needs to cover on-line, interstate betting as well.

Of particular interest to May 5th, 2022, meeting is NRS 427A, SERVICES TO AGING PERSONS AND PERSONS WITH DISABILITIES, point (b), "the best possible physical and mental health which science can make available and without regard to economic status." "GENERAL PROVISIONS, SERVICES TO AGING PERSONS AND PERSONS WITH DISABILITIES

NRS 427A.010 Declaration of legislative purpose. The Legislature finds and declares that:

1. The older people of our state are entitled to receive, and it is the joint and several duty and responsibility of the state and local governments to provide, within the limits of available resources, assistance to secure equal opportunity to the full and free enjoyment of the following objectives:

- (a) An adequate income in retirement.
- (b) The best possible physical and mental health which science can make available and without regard to economic status.
- (c) Suitable housing, independently selected, designed and located with reference to special needs and available at costs which older citizens can afford.
- (d) Full restorative services for those who require institutional care.
- (e) Opportunity for employment with no discriminatory personnel practices because of age.
- (f) Retirement in health, honor and dignity.
- (g) Pursuit of meaningful activity within the widest range of civic, cultural and recreational opportunities.
- (h) Efficient community services which provide social assistance in a coordinated manner and which are readily available when needed.
- (i) Immediate benefit from proven research knowledge which can sustain and improve health and happiness.
- (j) Freedom, independence and the free exercise of individual initiative in planning and managing their own lives.
- (k) The benefit of balanced nutrition.
- (l) Adequate day care center services.

At a presentation on elder abuse three years ago at Doolittle Senior Center by someone from the Las Vegas Metropolitan Police Department ("Metro"), the officer was careful to warn his listeners that offering to help seniors but not following through was against the law. Is there an implied caring aspect in casinos who have special marketing to seniors? I don't know. Our laws seem to be a balance of freedom and protection but perhaps leaning more towards freedom than protection. What do you think?

The Nevada Gaming Control Board (the Board) requires "each licensee that engages in the issuance of credit, check cashing, or the direct mail marketing of gaming opportunities, to implement a program containing the elements described below, as appropriate, that allows patrons to self-limit their access to the issuance of credit, check cashing, or direct mail marketing by that licensee."¹ The challenge to this, as Phillip Ryan's letter to the Board in April of 2013, is that self-limiting has to be done with every single licensee. There is no "integrated regulatory regime into state compacts which will ensure that all responsible gaming (money limits) are centrally administered." In the bad old days, even 10 years ago, one casino downtown had a bank set up shop inside the casino. Being a bank, they were not subject to the rules of the Board, and did not care if you had "self-limited" yourself. There needs to be one place to self limit and that needs to cover on-line, interstate betting as well.

"GENERAL PROVISIONS, SERVICES TO AGING PERSONS AND PERSONS WITH DISABILITIES

NRS 427A.010 Declaration of legislative purpose. The Legislature finds and declares that:

1. The older people of our state are entitled to receive, and it is the joint and several duty and responsibility of the state and local governments to provide, within the limits of available resources, assistance to secure equal opportunity to the full and free enjoyment of the following objectives:

- (a) An adequate income in retirement.
- (b) The best possible physical and mental health which science can make available and without regard to economic status.
- (c) Suitable housing, independently selected, designed and located with reference to special needs and available at costs which older citizens can afford.
- (d) Full restorative services for those who require institutional care.
- (e) Opportunity for employment with no discriminatory personnel practices because of age.
- (f) Retirement in health, honor and dignity.
- (g) Pursuit of meaningful activity within the widest range of civic, cultural and recreational opportunities.
- (h) Efficient community services which provide social assistance in a coordinated manner and which are readily available when needed.
- (i) Immediate benefit from proven research knowledge which can sustain and improve health and happiness.
- (j) Freedom, independence and the free exercise of individual initiative in planning and managing their own lives.
- (k) The benefit of balanced nutrition.
- (l) Adequate day care center services.
