

Any member of the City Council may substitute for a member of the Recommending Committee at any time.

Bill No. 2022-29 - For possible action - Amends LVMC Title 19 to add a new chapter governing bonuses and incentives for the development of affordable housing in replacement of existing provisions on the subject, and establishes an affordable housing trust fund. 5. Citizens Participation: Public comment during this portion of the agenda must be limited to matters within the jurisdiction of the Committee.
