The Planning Commission at a regular meeting held on *June 13, 2023* voted to recommend **APPROVAL** of the following Land Use Entitlement project request for a Major Amendment to a previously approved Special Use Permit (20-0204-SUP1) TO EXPAND A PROPOSED MONORAIL (TUNNEL) USE generally located beneath the rights-of-way of 4th Street, Bonneville Avenue, Desert Inn Road, Grand Central Parkway, Main Street, Martin L. King Boulevard, Ogden Avenue, Paradise Road, Rancho Drive, Robin Leach Lane, Sahara Avenue, St. Louis Avenue, Interstate 15, and U.S. Highway 95, Wards 1, 3 and 5 (Knudsen, Diaz, and Crear). 21-

This approval is subject to the following conditions:

Planning


1. Conformance to the approved conditions for Special Use Permit (20-0204-SUP1) shall be required except as amended herein.
2. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
3. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Building and Safety Division.
4. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for a building permit, as well as submitted as part of any business license application.
5. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.
