The Planning Commission at a special meeting held on *July 25, 2023* voted to **APPROVE** a request FOR THE PROPOSED ADDITION OF DIGITAL (LED) ELECTRONIC MESSAGE ILLUMINATION TO THE WEST FACE OF AN EXISTING OFF-PREMISE SIGN on 0.45 acres at 3720 West Desert Inn Road (APN 162-08-410-033), M (Industrial) Zone, Ward 3 (Diaz).

This approval is subject to the following conditions:

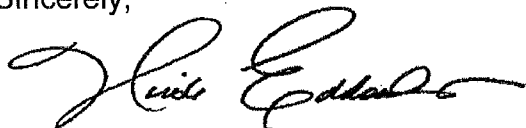
Planning

1. Conformance to the Conditions of Approval for Special Use Permit (U-0300-94) shall be required.
2. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
3. All development shall be in conformance with the site plan and sign elevations date stamped 05/02/23, except as amended by conditions herein.
4. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Building and Safety Division.
5. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
6. All City Code requirements and design standards of all City Departments must be satisfied, except as modified herein.
