The Recommending Committee may, thereafter, continue the hearing to a future date or formulate a recommendation to the City Council for passage, rejection or amendment of the proposed bill. Any member of the City Council may substitute for a member of the Recommending Committee at any time.

Items listed on the agenda may be taken out of the order presented; two or more agenda items for consideration may be combined; and any item on the agenda may be removed or related discussion may be delayed at any time. Bill No. 2023-17 - For possible action - Amends various provisions of LVMC Chapters 14.10 and 14.11 to update water conservation measures to be consistent with regulations of the Las Vegas Valley Water District; makes related changes to LVMC Title 19; and amends LVMC Chapter 16.28 to prohibit the use of evaporative cooling in new structures.
