Your Land Use Entitlement project request TO ALLOW A SEVEN-FOOT SIDE YARD SETBACK WHERE 10 FEET IS REQUIRED FOR A PROPOSED ADDITION TO A SINGLE-FAMILY DWELLING on 0.45 acres at 1101 Pine Island Court (APN 138-29-210-015), P-C (Planned Community) Zone [SF1 (Single Family Detached - 3.5 Units per Acre) Summerlin Special Land Use Designation], Ward 2 (Seaman) was considered administratively by the Department of Planning staff.
