

1 SECTION 2: Title 16, Chapter 16, Section 30, of the Municipal Code of the City of Las
2 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

3 **16.16.030:** (A) Whenever in this Chapter any act is prohibited or is made or declared to be unlawful
4 or an offense or a misdemeanor, or whenever in this Chapter the doing of any act is required or the failure to
5 do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of any such
6 prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon conviction
7 thereof, shall be punished by a fine of not more than one thousand dollars or by imprisonment for a term of
8 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation
9 of this Chapter shall constitute a separate offense.

10 (B) For a fireworks-related violation under Subsection (A) of this Section or Sections
11 109, 5601.1.3 or 5601.2.2 of the International Fire Code 2021 Edition, as adopted by the City, the minimum
12 fine for a first violation shall be five hundred dollars and, for a second or subsequent violation, one thousand
13 dollars.

14 [(B)] (C) As an alternative to a criminal prosecution under Subsection [(A)] (B) of this
15 Section, [or a proceeding under Section 109 of the International Fire Code adopted under this Chapter for a
16 violation of Section 5601.1.3 or 5601.2.2 of the International Fire Code, 2018 Edition, as those Sections are
17 adopted by the City,] the Department of Fire and Rescue may proceed by means of a civil proceeding in
18 accordance with the provisions of LVMC 6.02.400 to 6.02.460, inclusive. In the case of a civil proceeding
19 regarding such a violation:

20 (1) Any reference in LVMC 6.02.400 to 6.02.460, inclusive, to the
21 “Department” or “Business Licensing Division” or “Director” shall pertain to the Department of Fire and
22 Rescue, its Fire Prevention Division, or the City Fire Marshal, as the case may be.

23 (2) In lieu of the schedule of fines set forth in LVMC 6.02.460, the applicable
24 civil [fines are as follows:

25 (a) For a first offense, two hundred fifty dollars.

26 (b) For a subsequent offense within a twelve-month period,] fine shall

1 be five hundred dollars.

2 (3) In addition to the fine [amounts] described in Paragraph (2) above, the City
3 is entitled to recover an amount of restitution for the City's costs, if any, of disposing of any fireworks that
4 were the subject of the violation.

5 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
6 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
7 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
8 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
9 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
10 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
11 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

12 SECTION 4: Whenever in this ordinance any act is prohibited or is made or declared to
13 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required
14 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of
15 such prohibited act or the failure to do any such required act shall, except as otherwise provided by this
16 ordinance, constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more
17 than \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
18 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.
