The Planning Commission at a regular meeting held on *April 9, 2024* voted to **APPROVE** the following Land Use Entitlement project request TO ALLOW TWO PROPOSED SIGNS ON THE EASTERN ELEVATION WHERE ONE SIGN IS ALLOWED AND TO ALLOW A 19 PERCENT COVERAGE OF THE EASTERN TENANT SPACE ELEVATION WHERE 10 PERCENT IS THE MAXIMUM ALLOWED on 0.24 acres at 6060 Elton Avenue (APN 138-35-518-015), P-R (Professional Office and Parking) Zone, Ward 1 (Knudsen).

This approval is subject to the following conditions:

Planning

1. A Variance (24-0061-VAR1) is hereby approved, to allow two proposed signs on the eastern elevation where one sign is allowed.
2. A Variance (24-0061-VAR1) is hereby approved, to allow a 19 percent coverage of the eastern tenant space elevation where 10 percent is the maximum allowed.
3. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
4. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Building and Safety Division.
5. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
6. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.

This action by the Planning Commission on April 9, 2024 is final unless a written appeal is filed with the City Clerk within ten days of the date of the Planning Commission's decision as allowed by code or there is a review action filed by the City Council within the same time period. No building permits or business licenses related to these items shall be issued prior to the expiration of the required ten day waiting period, or until any filed appeal is resolved pursuant to LVMC Title 19.18.
