

Any member of the City Council may substitute for a member of the Recommending Committee at any time.

Items listed on the agenda may be taken out of the order presented; two or more agenda items for consideration may be combined; and any item on the agenda may be removed or related discussion may be delayed at any time. Bill No. 2024-16 - For possible action - Grants to Google Fiber Nevada, LLC, a non-exclusive franchise for the purpose of installing, operating and maintaining, within the City, communications services, including broadband internet service and/or telecommunications service, subject to and in accordance with the terms and conditions of the Franchise Agreement incorporated by reference into this Ordinance.
