

1 **RESOLUTION NO. R-26-2025**

2 **RESOLUTION CONCERNING THE AUTHORITY OF THE CITY MANAGER OF THE CITY OF**
3 **LAS VEGAS TO APPROVE AND ISSUE GRANT FUNDING**

4 WHEREAS, The City Manager of the City of Las Vegas (the "City"), as a matter of policy, has had
5 similar authority requiring contracts as has the Executive Director of the Redevelopment Agency of the City
6 of Las Vegas (RDA) regarding contracts of the RDA; and

7 WHEREAS, pursuant to Section 3.030(7) of the Las Vegas City Charter, the City Council may
8 authorize the City Manager to execute those contracts delegated to him or her by the Council; and

9 WHEREAS, in June 2010 the City Council approved a resolution (R-42-2010) to confirm that the
10 City Manager or a designee is authorized to approve and execute certain types of documents pertaining to
11 land use planning and development requests; and

12 WHEREAS, other types of documents have been identified as appropriate for approval and execution
13 by the City Manager or a designee; and

14 WHEREAS, the City finds that it is of benefit to the City to provide approval authority to include
15 such grants and related documents specific to the Redevelopment Areas; and

16 WHEREAS, the City intends to set forth in this Resolution the authorization for documents specific
17 to the Redevelopment Areas; and

18 WHEREAS, the delegation of grant approval and signing authority to the City Manager the execution
19 of agreements and approval of grant disbursements will facilitate the timely and efficient administration of
20 funds, eliminating the need for individual grant approvals by the RDA Board or City Council; and

21 WHEREAS, the City Council of the City of Las Vegas, by the addition of this Resolution, intends to
22 (i) authorize the City Manager of the City of Las Vegas, to execute those contracts, and agreements related
23 to grant funding, (ii) and or approve disbursements of funds for individual grants of up to five thousand
24 dollars (\$5,000).

1 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAS VEGAS HEREBY
2 RESOLVES as follows:

3 **1. Authority to approve and execute grants and grant agreements.**

4 (a) The City Manager is hereby authorized to approve and execute:

- 5 a. Any grants, agreements, and approval of disbursements of funds to businesses in the
6 Redevelopment Area provided the amount of such grant does not exceed five thousand
7 dollars (\$5,000),
8 b. Any modification excluding any increase to the grant amount (including time extension)
9 to a grant agreement,

10 The City Manager shall maintain a permanent record of each grant and grant modification approved
11 and executed pursuant to this authorization. Any grant or grant agreement in excess of the limits set forth
12 herein shall be submitted to the City Council of the City of Las Vegas for approval.

13 THE FOREGOING RESOLUTION was passed, adopted, and approved this 16th day of
14 April, 2025.


