Dear Applicant:

Your Land Use Entitlement project request FOR A PROPOSED RESTROOM ADDITION AT TULE SPRINGS RANCH AT FLOYD LAMB PARK on 697.78 acres at 9200 Tule Springs Road, (APN 125-04-301-005), C-V (Civic) Zone, Ward 6 (Brune)., was considered administratively by the Department of Community Development staff.

The Department of Community Development has administratively **APPROVED** your request subject to the following:

Planning

1. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
2. All development shall be in conformance with the site plan date stamped 10/31/2023, and the landscape plan, and building elevations, date stamped 08/08/23, except as amended by conditions herein.
3. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Building and Safety Division.
4. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
5. All City Code requirements and design standards of all City Departments must be satisfied, except as modified herein.

Public Works

6. Meet with the Flood Control Section of the Department of Public Works for assistance with establishing finished floor elevations and drainage paths for this site prior to submittal of construction plans, the issuance of any building or grading permits, whichever may occur first. Provide and improve all drainage ways as recommended.

Fire & Rescue

7. Applicant shall provide Fire apparatus access roads with an approved turn around and shall have a minimum width of not less than 24 feet. Turning radius shall be 28 feet inside turning radius and 52 feet outside turning radius.

This action by the Department of Community Development staff on **November 22, 2023** is final unless a written appeal is filed with the Director of the Department of Community Development within ten days of the date of this letter.
