Recommending Committee Agenda

The Recommending Committee will receive public input on each item of legislation being considered. The Recommending Committee may, thereafter, continue the hearing to a future date or formulate a recommendation to the City Council for passage, rejection or amendment of the proposed bill. Any member of the City Council may substitute for a member of the Recommending Committee at any time.

Items listed on the agenda may be taken out of the order presented; two or more agenda items for consideration may be combined; and any item on the agenda may be removed or related discussion may be delayed at any time. 3. Public Comment: Comment during this portion of the agenda must be limited to matters on the agenda for action. If you wish to be heard, come forward and give your name for the record. The amount of discussion, as well as the amount of time any single speaker is allowed, may be limited.
4. For possible action to approve the Final Minutes by reference of the November 17, 2025 Recommending Committee Meeting
5. Bill No. 2025-41 - For possible action - Amends LVMC 6.04.155 and 6.69.010 to update the definitions of the business licensing categories "Transportation Network Company" and "Reflexology", respectively, to align with State law. Proposed by: Seth T. Floyd, Director of Community Development
6. Bill No. 2025-42 - For possible action - Amends LVMC 6.02.150 to clarify the requirement that separate licenses or permits are needed for each assumed or fictitious business name that is associated with a business. Proposed by: Seth T. Floyd, Director of Community Development
7. Bill No. 2025-43 - For possible action - Updates the description of certain City ward boundaries (Wards 2, 3, 4, 5 and 6) to reflect precinct number adjustments by the Clark County Election Department. Proposed by: Dr. LuAnn D. Holmes, City Clerk

Bill No. 2025-44 - For possible action - An ordinance authorizing the issuance by the City of Las Vegas, Nevada, Various Purpose Revenue Bonds, Series 2026A (Tax-Exempt) and the City of Las Vegas, Nevada, Various Purpose Revenue Bonds, Series 2026B (Taxable) for the purpose of financing building projects. Proposed by Susan Heltsley, Chief Financial Officer
9. Citizens Participation: Public comment during this portion of the agenda must be limited to matters within the jurisdiction of the Recommending Committee. No subject may be acted upon by the Recommending Committee unless that subject is on the agenda and is scheduled for action.
