9 FOLLOWS:

10 SECTION 1: Title 1, Chapter 16, Section 30, of the Municipal Code of the City of Las  
11 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

15 SECTION 6: If any section, subsection, subdivision, paragraph, sentence, clause or phrase  
16 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by  
17 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the  
18 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby  
19 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase  
20 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,  
21 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

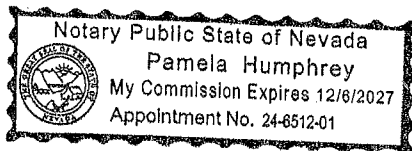
