

5. Discussion for possible action to install speed cushions on Fireside Ranch Avenue, Iron Crossing Avenue, Welch Valley Avenue, Dodds Canyon Street, and Palomino Ranch Street - Ward 6 (Brune)
6. Discussion for possible action to change the speed limit on Centennial Parkway between Shaumber Road and Grand Montecito Parkway - Ward 4 (Allen-Palenske)
7. Discussion for possible action to change the speed limit on Commerce Street between Oakey Boulevard and Charleston Boulevard from 30 MPH to 25 MPH - Ward 3 (Diaz)
