

1 **RESOLUTION AUTHORIZING THE GRANT OF UP TO \$85,000 DOLLARS**
2 **TO JUNIOR ACHIEVEMENT OF SOUTHERN NEVADA,**
3 **A NEVADA NON-PROFIT CORPORATION, FOR CITY OF LAS VEGAS BIZTOWN**
4 **STOREFRONT AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO**

5 WHEREAS, Junior Achievement of Southern Nevada (“Grantee”), is a Nevada non-profit
6 corporation established for educational purposes; and

7 WHEREAS, Grantee desires to continue to provide the city of Las Vegas (“City”) a standard
8 storefront in the Junior Achievement BizTown at the Junior Achievement Inspiration Center of Southern
9 Nevada (“Junior Achievement Storefront”); and

10 WHEREAS, in connection with the educational purposes of Grantee, the City Council desires to
11 grant to Grantee \$85,000 dollars (the “Grant Funds”) for use in connection with the City’s continued
12 sponsorship of the Junior Achievement storefront; and

13 WHEREAS, NRS 268.028 authorizes the governing body of a city to expend money for any purpose
14 that will provide a substantial benefit to the inhabitants of the City, including a grant to a non-profit
15 organization created for educational purposes; and

16 WHEREAS, NRS 268.028 further provides that such a grant of money must be made by means of a
17 resolution that specifies the purpose of the grant, the maximum amount to be expended from the grant, and
18 any conditions or other limitations on the expenditure of the grant; and

19 WHEREAS, the City Council desires that the City enters into the City of Las Vegas Storefront
20 Renewal Agreement with Grantee, which will provide the grant funds, as described herein, subject to the
21 conditions and other limitations described in this Resolution and as set forth in the City of Las Vegas
22 Storefront renewal Agreement, specifically for the use and benefit of Grantee for the Junior Achievement
23 Storefront; and

24 WHEREAS, the City Council finds that Grantee’s proposed use of the Grant Funds will provide a
25 substantial benefit to the inhabitants of the city of Las Vegas.

NOW, THEREFORE, BASED UPON THE FOREGOING, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAS VEGAS to grant the total amount of \$85,000 to Grantee, a Nevada non-profit corporation, for the continued sponsorship of the Junior Achievement Storefront.

RESOLVED FURTHER, that the City Council authorizes the Mayor of the City to execute the City of Las Vegas Storefront Renewal Agreement between the City of Las Vegas and Grantee, which will provide for the grant funds, as described herein, for the use and benefit of Grantee, and subject to the conditions and limitations as set forth in the Partner Activation Agreement.
