Dear Applicant:

The Planning Commission at a regular meeting held on *July 14, 2026* voted to **APPROVE** the following Land Use Entitlement project request TO ALLOW PROPOSED RESIDENTIAL ACCESSORY STRUCTURES [GARAGE AND POOL HOUSE] THAT DO NOT CONFORM TO TITLE 19.06 DEVELOPMENT STANDARDS FOR SETBACKS on 0.49 acres at 7400 Wittig Avenue (APN 125-22-111-050), R-E (Residence Estates) Zone, Ward 6 (Brune).

This approval is subject to the following conditions:

Planning

1. A Variance is hereby approved to allow a 10-foot corner side yard setback where 15 feet is required for a proposed Residential Accessory Structure [garage].
2. A Variance is hereby approved to allow a 10-foot corner side yard setback where 15 feet is required for a proposed Residential Accessory Structure [pool house].
3. This approval shall be void two years from the date of final approval, unless exercised pursuant to the provisions of LVMC Title 19.16. An Extension of Time may be filed for consideration by the City of Las Vegas.
4. All necessary building permits shall be obtained and final inspections shall be completed in compliance with Title 19 and all codes as required by the Building and Safety Division.
5. These Conditions of Approval shall be affixed to the cover sheet of any plan set submitted for building permit.
6. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.

July 15, 2026

This action by the Planning Commission on **June 16, 2026** is final unless a written appeal is filed with the City Clerk within ten days of the date of the Planning Commission's decision as allowed by code or there is a review action filed by the City Council within the same time period. No building permits or business licenses related to these items shall be issued prior to the expiration of the required ten day waiting period, or until any filed appeal is resolved pursuant to LVMC Title 19.18.
