RE: SUP-24780 - SPECIAL USE PERMIT

Dear Mr. Wood:

Your Request for a Special Use Permit FOR A PROPOSED SOCIAL SERVICE PROVIDER at 818 East Sahara Avenue (APN 162-03-801-046 and 059), C-1 (Limited Commercial) Zone, Ward 3 (Reese), was considered by the Planning Commission on November 8, 2007.

The Planning Commission voted to recommend **APPROVAL** of your request, subject to the following:

Planning and Development

1. Conformance to all minimum requirements under LVMC Title 19.04.010 for Social Service Provider use, including parking requirements.
2. This approval shall be void one year from the date of final approval, unless a business license has been issued to conduct the activity, if required, or upon approval of a final inspection. An Extension of Time may be filed for consideration by the City of Las Vegas.
3. The hours of operation for the Social Service Provider use shall be from 8:00 AM until 6:00 PM daily.
4. No meal service or food preparation shall be permitted in conjunction with the social services provided at this location.
5. All program participants accessing services shall be limited to a maximum stay of two hours per day.
6. This Special Use Permit shall be reviewed in one (1) year at which time the City Council may require the Social Service Provider use to cease activity on this site. The applicant shall be responsible for notification costs of the review. Failure to pay the City for these costs may result in a requirement that the Social Service Provider use cease activity on this site.

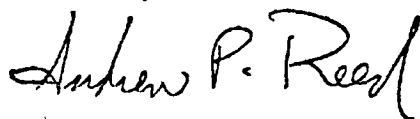
