Planning and Development

2. Replace "PLANNING AND DEVELOPMENT APPROVAL" with "CERTIFICATE OF DIRECTOR OF PLANNING AND DEVELOPMENT APPROVAL". 3. Within the title block, include the title of the map "GOLD SPIKE FINAL MAP 2."
