RE: FMP-14835 - Willows at Lone Mountain West

Dear Mr. Ritter:

Your request for a Final Map Technical Review was considered by the Planning and Development Department on August 7, 2006.

The Planning Development Department Staff has administratively **APPROVED** your request, subject to the following:

Planning and Development

1. The Original Final Map Mylar shall be in conformance with the approved Tentative Map – Willows at Lone Mountain West (TMP-5537).
2. The Final Map shall be revised in accordance with the corrections noted on the attached map as required by the Planning and Development Department prior to the submittal of the original Mylar for signature by the City. Such corrections shall include the following:
 - a. On the cover sheet, the name: “M. Margo Wheeler, AICP” shall be inserted between “Director of Planning and Development” and the signature line. Eliminate the duplicate signature block for the Planning and Development Department.
 - b. On the cover sheet, insert the file map number “FMP-14835” above the signature block in the lower right-hand corner.
 - c. Show the configuration of the right-of-way of and label the multi-use equestrian trail along Alexander Road that is to be or has been constructed.
 - d. Show the configuration of the right-of-way of and label the multi-use equestrian trail along the west property line (to be constructed with this development prior to Final Map recordation per Condition #1 of SDR-5519).
 - d. So building numbers are consecutive and begin and end at the entrance, show building numbers as noted below. (Please call me at 229-5915 should you have any questions concerning this requirement.)

Because the recreation building is part of the common area, the last building must be given building #12.

- e. The units shall be sequentially numbered in a counterclockwise direction around the building and end with the last unit at the "primary entrance." Since all the units are accessible from the exterior, the first unit shall be that unit to the right of center at the front of the building. (The front of the building is that side of the building that faces the primary vehicular access to the building.)
- f. Revise building details sheets to correspond to new numbering system.

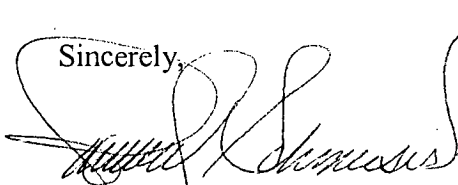
- 3. In the Owner's Certificate, clarify that rights-of-way are dedicated and easements are granted.
- 4. On the first sheet, revise the City Engineer's block to read: Jorge Cervantes, P.E #13977, P.T.O.E.
- 5. This site shall be responsible for sewer connection fees in accordance with condominium requirements per Title 14 Chapter 14.04.020 Equivalent Residential Unit (ERU) Schedule. If some or all of these units have already paid fees based upon apartment requirements, the difference between condominium and apartment fees for those units shall be paid to Building and Safety prior to the recordation of a Final Map for this site. Submit copies of the receipts to the Collection Systems Planning Section of the Department of Public Works with Final Map mylar submittal.
- 6. Per Condition of Approval #9 of Tentative Map TMP-5537, provide the following multi-use equestrian trail statement: "'?'-foot wide Multi-Use Equestrian Trail, C.E. Lot '?', Non-residential lot to be conveyed to the City of Las Vegas, to be privately maintained prior to conveyance". The following statement should be added to the end of the Owner's Certificate "I/we hereby acknowledge that non-residential lots (i.e. Lot '?') will be conveyed to the City of Las Vegas within one year of the recordation of this map". The Owner's Certificate should also include the trails statement as identified within the City of Las Vegas Title 18 Subdivision Ordinance.
- 7. Show Alexander Road as being dedicated by document #20020514:02056.
- 8. On sheet 2, add a note stating: "All Common Areas not occupied by a building are Public Drainage Easements to be Privately Maintained by the Homeowner's Association".
- 9. Site development to comply with all previous conditions of approval for the Willows at Lone Mountain West Tentative Map.

10. Prior to recordation, this Final Map must show all required easements and right-of-way dedications, must coincide with the approved drainage plan/study and construction plans, and the Owner's Certificate must make specific reference to all easements and right-of-ways noted/offered for public use as required by the Department of Public Works. Appropriate sight visibility restriction zones, if applicable, are also required to be shown on this Final Map at all interior intersections, at all perimeter intersections abutting this subdivision site, at all intersections where an interior subdivision street connects with an abutting public street and at all other locations as required by the Traffic Engineer.

This action by the Planning and Development Department on August 7, 2006 is final unless a written appeal is filed with the Director of Planning and Development within seven days of receiving written notice of the decision. A nonrefundable fee must accompany the appeal. The Planning Commission shall hear the appeal within 30 days after the appeal is filed with the Director.
