Dear Mr. Yamanini:

The City Council at a regular meeting held September 21, 2005 APPROVED the request for a Special Use Permit FOR A PROPOSED 80-FOOT TALL WIRELESS COMMUNICATION FACILITY, STEALTH DESIGN at 4480 East Charleston Boulevard (APN 140-32-401-005), C-1 (Limited Commercial) Zone. The Notice of Final Action was filed with the Las Vegas City Clerk on September 22, 2005. This approval is subject to:

Planning and Development

1. The approval is for one 65-foot pole to be constructed with the pine tree stealthing.
2. Conformance to all Minimum Requirements under Title 19.04.040 for a Wireless Communication Facility, Stealth Design use.
3. This Special Use Permit shall expire two years from the date of final approval, unless it is exercised or an Extension of Time is granted by the City Council.
4. The communications tower and its associated equipment and facility shall be properly maintained and kept free of graffiti at all times. Failure to perform the required maintenance may result in fines and/or removal of the communications Monopine and its associated equipment and facility.

Public Works

5. The proposed wireless communications facility shall not be located within the public right-of-way, existing or proposed public sewer or drainage easements, or interfere with Site Visibility Restriction Zones.

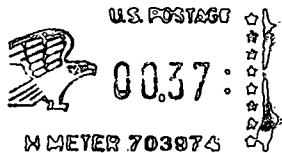
