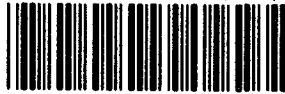

ORDINANCE NO. 5651

AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE CITY, TO PARTICULARLY DESCRIBE THE LAND TO BE ANNEXED, TO MAKE ITS INHABITANTS SUBJECT TO THE LAWS, OBLIGATIONS AND BENEFITS OF THE CITY, AND TO PROVIDE FOR OTHER RELATED MATTERS. (ANX-3087)

Sponsored by: Councilman Michael Mack

Summary: Annexes various parcels described generally as located north of Centennial Parkway, east of Puli Road, south of Grand Teton Drive and west of Hualapai Way.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: The corporate limits of the City of Las Vegas, Nevada, are hereby extended to annex, include, and make a part of the City of Las Vegas, Nevada, the following described real property:

Portion of Section 13 and Portions of Section 24, all in Township 19 South, Range 59 East, M.D.M., in the County of Clark, State of Nevada, described as follows:

PARCEL 1

The East Half (E 1/2) of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section 13.

PARCEL 2

The West Half (W 1/2) of the Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of said Section 24, being Lot 1 and Lot 2 as shown on LAND DIVISION 66-81, recorded May 14, 1981 in Book 1400 as Instrument Number 1359968 of Clark County,

18 Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of said Section 24.

19 PARCEL 6

20 The Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of the
21 Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of said
22 Section 24, being Parcel 1 as shown on LAND DIVISION 51-79, recorded
23 May 22, 1979 in Book 1059 as Instrument Number 1018736 of Clark
24 County, Nevada Records, and adjacent half street right of way of DEER
25 SPRINGS WAY (40 foot wide half street) and half street right of way of
26 ORNELIS STREET (now MICHELL CREST WAY 30 foot wide half
27 street), together with 20 foot radius spandrel area in the northwest corner of
28 said Parcel 1 as dedicated by GRANT, BARGAIN, SALE DEED recorded
May 22, 1979 in Book 1059 as Instrument Number 1018737 of Clark
County, Nevada Records.

SECTION 2: The City Council hereby determines that the described territory
meets the requirements provided by law for annexation to the City for the following reasons:

- A. The area to be annexed was contiguous to the City's boundaries at the
time the annexation proceedings were instituted;
- B. More than one-eighth (1/8) of the aggregate external boundaries of
the area are contiguous to the City;
- C. The territory proposed to be annexed is not included within the
boundaries of another incorporated city or within the boundaries of
any unincorporated town as those boundaries existed as of July 1,

1. 1983;

2 D. The City is eligible to annex the described territory since the
3 landowners have signed a petition constituting one hundred percent
4 (100%) of the owners of record of individual lots or parcels of land
5 within the annexation area.

6 SECTION 3: The City will provide police protection through the Las Vegas
7 Metropolitan Police Department, fire protection, street maintenance, and library services
8 immediately upon annexation. Garbage collection by the company franchised by the City
9 will also be provided immediately. The City sanitary sewer system will serve the proposed
10 annexation area. Any connection to or extension of this sewer line to serve the annexation
11 area shall be at the expense of the landowners. Other services, such as participation in the
12 City's recreational programs, special education classes and programs, public works planning,
13 building inspections, and other City services will also be available immediately. Utilities
14 such as gas, electricity, telephone, and water are provided by private utility companies and
15 other services to the area will not be affected by annexation. Street paving, curbs and gutters,
16 sidewalks and street lights which are not in place at the time of annexation will be installed
17 in the presently developed areas upon the request of the property owners and at their expense
18 by means of special assessment districts. Such improvements will be extended into the
19 undeveloped areas as development takes place and the need therefor arises, and will be
20 located according to the needs of the area at that time. Such installations will also be made
21 at the expense of the property owners, either by means of special assessment districts or as
22 prerequisites to the approval of subdivision plats, building permits or other land use or
23 development applications.

24 SECTION 4: The annexation of the described territory shall become
25 effective on the 12th day of December, 2003, and on that date the City will have the funds
26 appropriated in sufficient amount to finance the extension into the described territory of
27 police protection, fire protection, street maintenance, street sweeping, and street lighting
28 maintenance.

1 SECTION 5: The described territory, together with the inhabitants and
2 property thereof, shall, from and after the 12th day of December, 2003, be subject to all
3 debts, laws, ordinances and regulations in force in the City and shall be entitled to the same
4 privileges and benefits as other parts of the City, and shall be subject to municipal taxes
5 levied by the City.

6 SECTION 6: The City Engineer is hereby instructed to cause to be prepared
7 an accurate map or plat of the described territory and to record the map or plat, together with
8 a certified copy of this ordinance, in the office of the County Recorder of Clark County,
9 Nevada, which recording shall be done prior to the 12th day of December, 2003.

10 SECTION 7: The described territory, which previously has been zoned R-U
11 (County of Clark classification), is hereby classified as U (PCD) (City of Las Vegas
12 classification), which is deemed to be the City equivalent of the County classification.

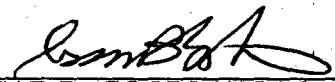
13 SECTION 8: If any section, subsection, subdivision, paragraph, sentence,
14 clause of phrase in this ordinance or any part thereof, is for any reason held to be
15 unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such
16 decision shall not affect the validity or effectiveness of the remaining portions of this
17 ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares
18 that it would have passed each section, subsection, subdivision, paragraph, sentence, clause
19 or phrase thereof irrespective of the fact that any one or more sections, subsections,
20 subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid
21 or ineffective.

22 SECTION 9: All ordinances or parts of ordinances, sections, subsections,

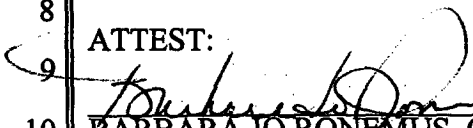
1 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las

5 title to the City Council as first read and adopted by the following vote:

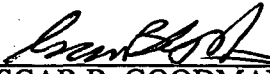

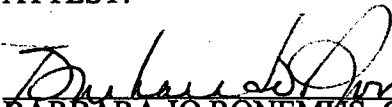

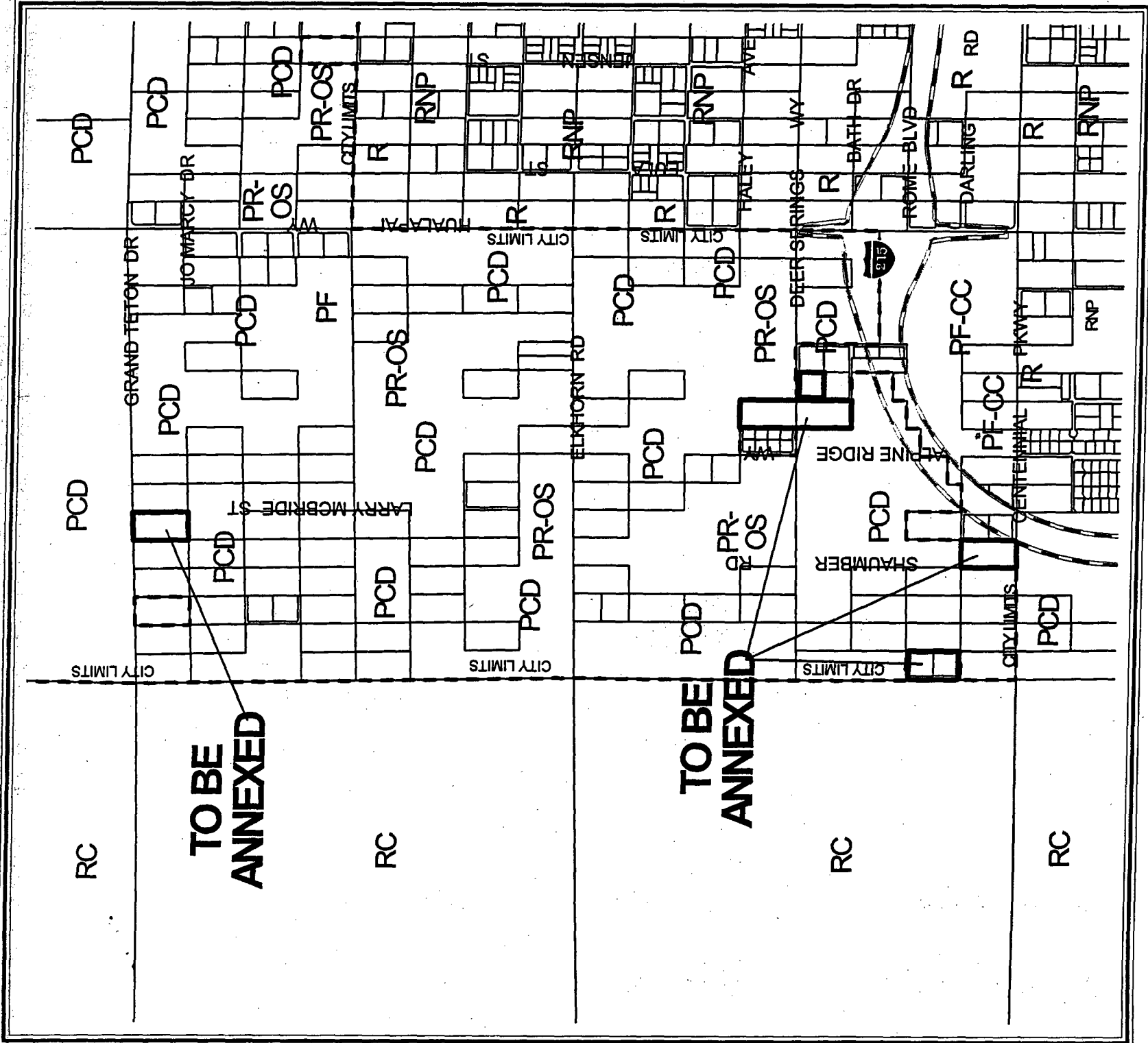
