Your request for a Final Map Technical Review was considered by the Planning and Development Department on October 14, 2003.

The Planning Development Department Staff has administratively **APPROVED** your request, subject to the following:

Planning and Development

1. The Reversionary Final Map shall be revised in accordance with the corrections as required by the Planning and Development Department prior to the submittal of the original mylar for signature by the City.
2. At the time of recordation of the Reversionary Final Map Mylar a blueline copy of the recorded Map Mylar shall be submitted to the Planning and Development Records Department

Public Works

3. Modify the Owner's Certificate to reflect the correct property owners as shown on the vesting deed for this property.
4. Comply with all previous conditions of approval for Site Development Plan Review SDR-2146 and all other subsequent site-related actions.
5. Prior to recordation, this Reversionary Final Map must show all required easements and right-of-way dedications, must coincide with the approved drainage plan/study and construction plans, and the Owner's Certificate must make specific reference to all easements and right-of-ways noted/offered for public use. Appropriate site visibility restriction zones, if applicable, are also required to be shown on this amended final map at all interior intersections, at all perimeter intersections abutting this subdivision site, at all intersections where an interior subdivision street connects with an abutting public street and at all other locations as required by the Traffic Engineer.

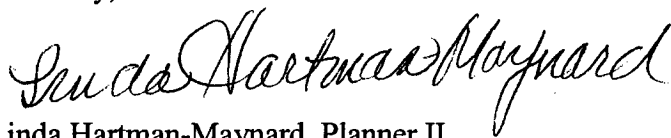
