The Notice of Final Action was filed with the Las Vegas City Clerk on April 3, 2003. This approval is subject to:

1. Only the east 200 feet of Assessor's Parcel Number 138-02-202-011 shall be rezoned to C-1 (Limited Commercial). The remainder of the property shall remain as C-2 (General Commercial)
2. The Assessor's Parcel Numbers 125-07-601-002, 125-08-401-004, 138-02-814-009 and 138-02-814-012 are hereby deleted from this request.

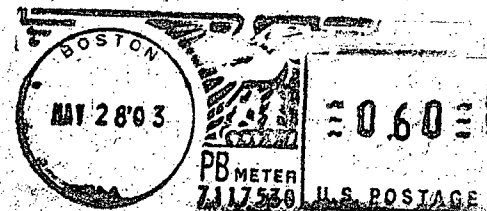

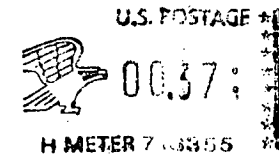
