AN ORDINANCE RELATING TO ICE CREAM TRUCKS; AMENDING TITLE 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1983 EDITION, BY ADDING THERETO A NEW CHAPTER TO PROVIDE LICENSING REGULATIONS AND STANDARDS FOR ICE CREAM TRUCKS; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Establishes licensing regulations and standards for ice cream trucks.
