**Ordinance No. 5041**

AN ORDINANCE RELATING TO OUTDOOR PAY TELEPHONES; AMENDING TITLE 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1983 EDITION, BY ADDING THERETO A NEW CHAPTER TO ESTABLISH REGULATIONS AND STANDARDS FOR OUTDOOR PAY TELEPHONES ON PUBLIC AND PRIVATE PROPERTY; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Establishes regulations and standards for outdoor pay telephones on public and private property.
