Ordinance No. 5099

AN ORDINANCE RELATING TO MISDEMEANOR DRUG ACTIVITY; AMENDING TITLE 10, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW CHAPTER 90 TO ALLOW THE MUNICIPAL COURT TO SUSPEND PERIODS OF INCARCERATION OF PERSONS CONVICTED OF MISDEMEANOR DRUG RELATED OFFENSES SUBJECT TO SPECIFIED CONDITIONS, INCLUDING STAYING OUT OF AN AREA IDENTIFIED AS THE "ORDER OUT CORRIDOR"; DEFINING THE TERM "ORDER OUT CORRIDOR"; PROVIDING FOR MANDATORY JAIL TIME FOR A THIRD OR MORE VIOLATION OF A MUNICIPAL COURT ORDER OUT ORDER WITHIN THREE YEARS; PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Authorizes the Municipal Court to suspend a defendant's sentence of incarceration for a misdemeanor conviction related to drug activity subject to specified conditions, including staying away from the "Order Out Corridor".

The above and foregoing ordinance was first proposed and read by title to the City Council on the 24th day of August, 1998 and referred to the following committee composed of Councilmen McDonald and Brown for recommendation; thereafter the said committee reported favorably on said ordinance on the 28th day of September, 1998, which was a regular meeting of said City Council; and that at said regular meeting the proposed ordinance was read by title to the City Council as amended and adopted by the following vote:
