ORDINANCE NO. 5089

AN ORDINANCE RELATING TO DEVELOPMENT AGREEMENTS AUTHORIZED BY TITLE SUBCHAPTER 19A.18.090 OF THE ZONING CODE OF THE CITY OF LAS VEGAS, ADOPTED AS AND INCORPORATED IN TITLE 19A OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION; ADOPTING THAT CERTAIN DEVELOPMENT AGREEMENT BETWEEN THE CITY OF LAS VEGAS AND JACK AND LAURA SOMMER, ET AL., DATED DECEMBER 18, 1991; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Formally adopts the 1991 development agreement concerning the Mountain Spa project.
