ORDINANCE NO. _____

AN ORDINANCE RELATING TO ZONING; AMENDING CHAPTER 19A.06 OF THE ZONING CODE OF THE CITY OF LAS VEGAS, AS ADOPTED BY AND INCORPORATED IN TITLE 19A OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO A NEW SUBCHAPTER 100 TO CREATE THE DOWNTOWN CASINO OVERLAY DISTRICT; AMENDING A PORTION OF SECTION 19A.04.040(C) OF SAID ZONING CODE BY AMENDING THE DEFINITION OF THE TERM "NUDE SHOW" TO EXCLUDE THEREFROM A SHOWROOM IN A RESORT HOTEL AND CASINO WITH OVER 300 ROOMS WHICH IS LOCATED WITHIN THE DOWNTOWN CASINO OVERLAY DISTRICT; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Creates the Downtown Casino Overlay District and amends the zoning regulations governing sexually oriented businesses to exclude from the definition of "nude show" a showroom in a resort hotel and casino with over 300 rooms which is located within that District.
