ORDINANCE NO. 5074

AN ORDINANCE RELATING TO ZONING; AMENDING TABLE 2 OF THE LAND USE TABLES ADOPTED IN SUBCHAPTER 19A.04.010 OF THE ZONING CODE OF THE CITY OF LAS VEGAS, ADOPTED AS AND INCORPORATED IN TITLE 19A OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO REQUIRE A SPECIAL USE PERMIT FOR SERVICE STATION USES IN THE C-1 AND C-2 ZONING DISTRICTS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Sponsored by: Councilman Arnie Adamsen Summary: Amends the Zoning Code to require a special use permit for service station uses in the C-1 and C-2 Zoning Districts
